**Supply.** An automatic distribution will be made only to post offices with philatelic centers. All other post offices should order sufficient quantities of the envelope to meet anticipated local philatelic demand. Submit Form 3205, *Requisition for Plain Stamped Envelopes*, to U.S. Stamped Envelope Agency, Williamsburg, PA 16693 (see instructions in Section 526, F-1 *Financial Handbook for Post Offices*), using **Item 654** for size 6¾ and **Item 154** for size 10. Orders will be filled as fast as manufacturing and distribution facilities permit. The envelope will be available only in sizes 6¾ and 10 regular.

**Printed Stamped Envelopes.** Postmasters may accept customers' requests for the 20-cent Purple Heart stamped envelopes with printed return address. Allow the usual four weeks for delivery. No orders can be dispatched before August 6, 1982.—*Customer Services Dept., 7-8-82.*

## NONBARGAINING PAY CHANGES

Effective July 24, 1982, career nonbargaining EAS employees and EAS A-E Postmasters will receive a 3 percent general increase in basic salary. Salary schedules will be adjusted upward by 3 percent at the same time. As a result of the raising of the \$50,112 Federal Executive salary ceiling in January 1982, the 3 percent increase was assured in lieu of a 1.5 percent increase and one-time lump-sum cash payments set for July 1982 and July 1983. An additional 1.5 percent general increase will be granted July 23, 1983.

Also, effective July 24, 1982, the salary cutoff for receiving COLA will be increased from \$45,000 to \$50,000. The current 75 percent formula for determining COLA for EAS-24s and above will continue to be in effect.

In addition to the 3 percent general increase for all EAS grades, the maximum for the salary ranges for EAS-27 through EAS-30 will be further increased as shown below.

### Correction

#### Address List Sequencing

The following is a correction to an article of the same title which appeared on page 1 of POSTAL BULLETIN 21356 (6-17-82) in which paragraphs 4, 5, and 6 had misplaced lines.

The revised regulations to the DOMESTIC MAIL MANUAL (DMM) 945.3 regarding the Address List Sequencing Service became effective on September 1, 1981. The revisions were published in POSTAL BULLETINS 21310 (8-6-81) and 21326 (11-19-81). In addition Management Instruction DM 940-81-2 (10-26-81) was sent to all postal delivery units outlining the guidelines for the proper handling of address lists.

As a reminder, the following procedures must be followed to ensure the timely and safe return of address list cards to the mailer.

1. The MSC Director of Customer Services, or designee, must maintain a control record which includes the name and address of the mailer; number of cards and routes received; post office responsible for sequencing and correction; date received at the MSC; due date for return of sequenced cards to the mailer by the responsible, local post office; and due date for the returned copy of a completed *Delivery Unit Summary Sheet* to the MSC coordinator.

2. The MSC coordinator must send the cards to the responsible post offices or postal delivery units on the day the cards are received at the MSC.

3. The responsible post office must complete the sequencing and corrections promptly.

4. Unless the mailer requests to pick up the cards, the responsible post office must return the cards to the mailer directly within 15-days from the date the cards were originally received at the MSC or local post office.

5. When returning the cards to the mailer in the mail, use the original cartons provided by the mailer. If for some reason, the original cartons have been damaged and cannot be used for remailing, then the responsible post office must carefully pack the cards in another suitable container and properly relabel for mailing.

6. In all cases, the cards must be returned under Penalty label and endorsed to the mailer First Class or Priority Mail. In no case, may these cards be returned Third- or Fourth-Class Mail or Postage Due.—*Delivery Services Dept., 7-8-82.*

### Life Insurance Program

Employees who did not elect Basic Life, Option A-Standard, or Option B-Additional insurance during the 1981 open enrollment period may now obtain such coverage if they meet all of the following requirements.

(Note: Failure to elect Basic Life insurance is termed *waiver* and failure to elect Optional life insurance is termed *declination*.)

- (1) They are under age 50,
- (2) One year has elapsed since the effective date of their last waiver or declination, and
- (3) They furnish at their own expense, satisfactory evidence of insurability.

Requests for cancellation of a waiver or a declination are made on SF 2822, *Request for Insurance*. After the Office of Federal Employees Group Life Insurance approves the SF 2822, the employee has 31 days in which to make the desired elections.

After a waiver or declination has been officially cancelled (or an event permitting election has occurred—(see SF 2817B, Part II, General Information), the employee completes SF 2817, *Life Insurance Election*, electing the desired coverage by signing and dating the applicable block.

Care should be taken in completing SF 2817 to insure that the employee does not lose coverage because the form has not been properly completed. If the employee does have previously elected coverage and wishes to continue such coverage, the applicable election blocks must be signed and dated as though it is a new election. A notation is to be made within the particular block, indicating the actual date this coverage was previously elected. The official certifying the SF 2817 is responsible for the accuracy of this date.

Part 1 and Part 2 of the SF 2817 are to be filed in the employee's official personnel folder. (Part 2 is retained to verify insurance codes.) Previous SF 2817s and SF 176s in the folder are to be retained and not destroyed. A Form 50A is required for all changes to an employee's life insurance coverage.

When completing SF 2821, *Agency Certification of Life Insurance*, in retirement and Office of Workers Compensation cases, all SF 2817s (and SF 176s) in the employee's personnel folder are to be thoroughly reviewed to ensure that Items 8, 9, 10, and 11 on the SF 2821 correctly establish whether or not the employee is eligible to continue life insurance coverage.—*Employee Relations Dept., 7-8-82.*

## Purple Heart Embossed Stamped Envelope

A 20-cent embossed stamped envelope honoring the 200th anniversary year of The Order of the Purple Heart for Military Merit, commonly called "The Purple Heart," will be issued August 6 in Washington, DC. The first day of issue ceremony will be held at the Pentagon.

The Purple Heart is the world's second oldest military decoration still in use. It was established by General George Washington at Newburgh, NY., on August 7, 1782, during the American Revolutionary War. The Purple Heart is awarded to any person wounded in action while serving in the armed forces of the United States. The Medal is also awarded posthumously to persons killed in action or who die of wounds received in action.

The original badge was made of purple silk and sewn on the left breast of the uniform coat, over the heart. On February 22, 1932, the War Department revived the decoration to pay tribute to George Washington. The design of the stamp features the revised medal which consists of a heart-shaped medal featuring the bust of George Washington on purple enamel. The Washington coat of arms is incorporated in the ring with which it is attached to a purple

ribbon bordered with a narrow white stripe.

Procedures for ordering first day cancellations are as follows:

Customers are urged to buy their own embossed envelopes at their post office and mail their order no later than September 5 to: Customer-Provided Stationery, Postmaster, Washington, DC 20066-9991. There is no charge. Uncanceled stamps issued before August 6 may be affixed to the embossed envelope to receive the first day cancellation. Orders containing embossed envelopes to which stamps issued after August 6 are affixed will be returned unserved.

The Postal Service will provide embossed envelopes when requested to do so. Mail orders to: Purple Heart Embossed Envelope, Postmaster, Washington, DC 20066-9992. The price per envelope is 24 cents. The 6¾ regular envelope will be supplied unless the Number 10 envelope is specifically requested. Personal checks in the exact amount will be accepted as payment for orders up to the limit of 50 covers. Do not send cash. Postage stamps are unacceptable as payment. Orders must be postmarked by September 5.

**Supply.** All post offices under the automatic distribution will receive an initial supply of this stamp.

Post offices with 950 or more revenue units requiring additional bulk quantities (**Item 422**) should immediately submit a Form 3356, *Stamp Requisition-Bulk Quantities*, to the Bureau of Engraving and Printing. All post offices requiring additional stamps in less-than-bulk quantities should immediately requisition them on a separate Form 17, *Stamp Requisition*, from their Stamp Distribution Office.

Before requisitioning additional stock, consider that the stock should be depleted prior to October 3, 1982, at all post office outlets, except designated philatelic windows.—*Customer Services Dept.*, 7-8-82.

## International Mail—Parcel Post Customs Declaration

International exchange offices are receiving out-bound foreign parcels bearing an incomplete Form 2966-A, *Parcel Post Customs Declaration*. Accepting employees have omitted indicating on the customs declaration the amount of postage paid and the weight of the parcel.

The postage and weight information has a twofold purpose. First, it assists international exchange offices in their revenue protection duties. Parcels are checked to ensure that the correct amount of postage was paid based on the weight of the parcel. Second, the weight information is required for international mail documents which must be completed by the exchange office.

Omission of this information makes it necessary for international exchange offices to weigh the parcels and then determine if the correct amount of postage was paid. This situation unnecessarily delays the parcels and increases costs at the international exchange offices.

Employees are reminded of acceptance procedures which are outlined in the *INTERNATIONAL MAIL MANUAL*, 327.2.—*Rates & Classification Dept.*, 7-8-82.

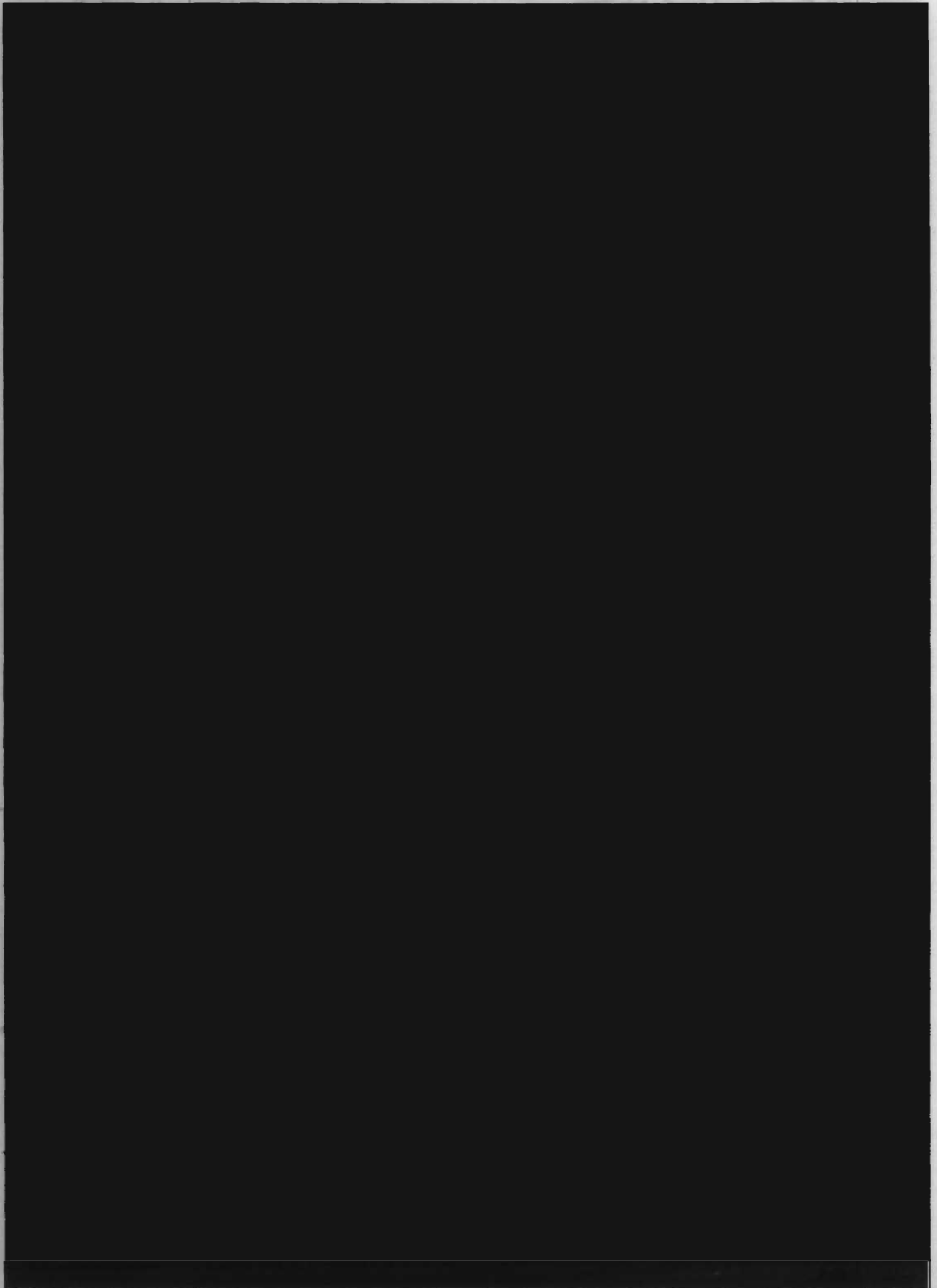
## Step 14, Phased Postage Rates

The Step 14 Phased Postage Rates announced in *POSTAL BULLETIN* 21353 (5-27-82) were effective at 12:01 a.m., July 6, 1982. These are the only domestic rates affected by the phase-in. All other domestic rates remain the same.

Postmasters must be sure that all window and bulk mail acceptance personnel are familiar with the new rates in order to prevent a possible loss of revenue.

If copies of the April 1982 edition of Form 3541, *Statement of Mailing—Second-Class Pubs Except Controlled Circulation Publications*, have not been received, the correct applicable rates must be written on the December 1981 edition of Form 3541.—*Rates & Classification Dept.*, 7-8-82.

# Jackie Robinson Commemorative Stamp

A 20-cent commemorative stamp honoring Jackie Robinson, the famed American baseball player, will be issued August 2 in Cooperstown, New York. The first day of issue ceremony will be held at the Baseball Hall of Fame, prior to the annual Hall of Fame baseball game at Doubleday Field.

Jackie Robinson was the first black man to play major league baseball. The pioneer athlete broke major league's baseball color barrier in 1947, when he signed with the Brooklyn Dodgers. Robinson was voted rookie of the year in 1947 and the National League's most valuable player in 1949. In 10 seasons with the Dodgers, Robinson's timely hitting and aggressive base running helped the team win six pennants and one World Series. He retired after the 1956 season and engaged in political, business, and civil rights activities. He was elected to the Baseball Hall of Fame in 1962.

The Jackie Robinson stamp is the fifth issue in the Black Heritage USA Series. Previous stamps have honored Harriet Tubman, Dr. Martin Luther King, Jr., Benjamin Ban-

The Postal Service will affix stamps when requested to do so. Mail orders by September 1 to: Jackie Robinson Stamp, Postmaster, Cooperstown, NY 13326-9992. The cost is 20 cents per stamp to be affixed and personal checks in the exact amount will be accepted for orders up to the limit of 50 covers. Do not send cash. Postage stamps are unacceptable as payment.
