The British Colony of Natal, Africa, a  
Member of the Universal Postal Union.

The adhesion of the British Colony of Natal, Africa, to the Universal Postal Convention and the Regulations for its execution, signed in Vienna on the 4th of July, 1891, having been announced through the proper diplomatic channel, articles of mail matter for and from the Colony of Natal will be subject, in the United States, on and after July 1, 1892, to the postage rates and conditions applicable to articles of a similar nature addressed to or received from the other countries and colonies embraced in the Universal Postal Union.

Reduction of Postage Rates on Mail Matter for Certain Countries Foreign to the Universal Postal Union.

The attention of postmasters and others is called to the following extract from an order of the Postmaster General dated the 1st instant, reducing the postage rates and modifying the conditions applicable in the United States, on and after July 1, 1892, to articles of mail matter addressed to the destinations not embraced in the Universal Postal Union therein named, viz:

"ORDERED, That on and after the 1st of July, 1892, the postage rates of 10 cents per one-half ounce or fraction of one-half ounce for letters, and 2 cents for each 2 ounces or fraction of 2 ounces for 'printed matter' of all kinds, 'commercial papers' and 'samples of merchandise,' shall be applicable in the United States to articles addressed to the Islands of Ascension and Saint Helena, places in China, Madagascar and Morocco, at which Postal Union post offices have not been established, Bechuanaland, Cape Colony, including Basutoland, Caffraria and Griqualand, Orange Free State, and the Transvaal or South African Republic.  
"Prepayment of at least one full rate of postage shall be 'compulsory;' the conditions relative to size, weight and wrapping, applicable to similar articles in mails exchanged between countries of the Postal Union shall apply likewise to 'printed matter,' 'commercial papers' and 'samples' for the Non-Union destinations named herein; and the minimum charge for packages of 'commercial papers' shall be 5 cents."

The rates and conditions prescribed in the foregoing extract takes the place of the rates and conditions prescribed for articles addressed to the same destinations as stated in the "Foreign Postage Table," on pages 888-897, and on page 23 of the United States Official Postal Guides for January and February, 1892, respectively.

Postmasters will cause due notice of the above to be taken at their offices.
