ORDER No. 1268.

ORDERED: The International Bureau of the Universal Postal Union at Berne, Switzerland, having advised this Department, under date of the 8th ultimo, that the Republic of Panama on the 11th of June, 1904, adhered to the Universal Postal Convention signed at Washington on the 15th of June, 1897, articles mailed in the United States addressed for delivery in the Republic of Panama are subject to the rates of postage and to the conditions applicable to articles mailed in the United States addressed for delivery in other countries and colonies of the Universal Postal Union; said rates being as follows, viz:

Letters, 5 cents for each half ounce or fraction of half ounce.

Postal Cards, single, 2 cents; with paid reply, 4 cents each.

Prints, 1 cent for each weight of two ounces or fraction of two ounces.

Commercial Papers, 1 cent for each weight of two ounces or fraction of two ounces, with a minimum charge of 5 cents.

Samples of Merchandise, 1 cent for each weight of two ounces or fraction of two ounces, with a minimum charge of 2 cents.

Registration Fee, 8 cents.
