# Pilgrim Tercentenary Commemorative Postage Stamps.

THIRD ASST. POSTMASTER GENERAL,
Washington, December 14, 1920.

1. Notice is hereby given of the issuance of a special series of postage stamps in commemoration of the tercentenary of the landing of the Pilgrims, in December of 1620. These stamps are issued in pursuance of section 4 of public resolution No. 42, Sixty-sixth Congress, approved May 13, 1920, providing as follows:

DESCRIPTION.

2. The stamps are issued in three denominations, as follows:

2-cent, red; subject, "The Mayflower."
2-cent, red; subject, "Landing of the Pil-5-cent, blue; subject, "Signing of the Com-

The dimensions of the stamps are approximately 1½ by ½ inches. In a straight horizontal line at the top are the words "Pilgrim Tercentenary"; directly below, at left and right, are the years "1620" and "1920." Beneath the subject years "1620" and "1920." Beneath the subject appears its title upon a curving ribbon. Within circles in the two lower corners are numerals of denomination, with the word "cents" in a straight horizontal line between. The border at the left of the picture presents a vertical row of hawthorn blossoms (the British mayflower); the border at the right contains a row of trailing arbutus (the American mayflower, which tradition says was named by the Pilgrims after their ship).

3. The Pilgrim tercentenary stamps are valid for all postage purposes and for registry, airplane, and special-delivery service when used in accordance with regulations relating thereto.

4. The stamps will be issued in sheets of 70, and for the larger post offices in banded packages of 100 sheets (7,000 stamps).

5. Central-accounting postmasters will be sent an initial supply of Pilgrim tercentenary stamps without requisition, and will issue them to district postmasters in response to requisitions, drawn on form 3338 in accordance with sections 47 and 171, pages 34 and 49, 1920 Postal Guide.

6. Direct-accounting postmasters may obtain

6. Direct-accounting postmasters may obtain Pilgrim tercentenary stamps by requisition upon the Third Assistant Postmaster General. Division of Stamps, on Form 3201, the words "Pilgrim issue" to be written plainly at the top of the blank. The requisitions must report in the proper column the number of Pilgrim tercentenary stamps on hand, and the total quarterly sales of postage stamp stock of all kinds. They must also be indorsed as to protection against burglary as required by sections 51, 52, and 59, page 34, 1920 Postal Guide. Stock other than Pilgram stamps must not be included in the same requisition.

7. After the initial supply, central-accounting postmasters may obtain additional Pilgrim tercentenary stamps in the manner prescribed in section 6 hereof.

8. Requisitions will not be expedited, but will be filled in regular course in the order of

will be filled in regular course in the order of receipt by the department.

9. If requisitions are reduced or delayed in filling, postmasters will understand that it is because the department's supply of Pilgrim tercentenary stamps is not equal to the demand. If the department finds it necessary to reduce a requisition, the remaining stamps will only be supplied in response to a new requisition, which may be drawn in time to prevent the postmasmay be drawn in time to prevent the postmaster's stock from becoming exhausted.

10. Pilgrim tercentenary stamps shall be sold

by postmasters only upon request, as the de-partment's supply is not sufficient to displace the regular issue of postage stamps.

Postmasters accepting parcels for insurance or collection on delivery must make certain that the regulation "Insured" or C. O. D. stamp is conspicuously impressed on the address (face) side of the wrapper.

Great care must be exercised in the examination of incoming parcels to detect and properly handle all insured and C. O. D. mail, being particular to collect C. O. D. charges on delivery. When a C. O. D. parcel is received without tag attached, a new tag should be prepared, marked attached, a new rag shows.
