May 15, being the tenth anniversary of the regular transportation of mail by air, I have caused to be designated the week begin-

ning May 14 as "Air Mail Week."

Postmasters are directed to bring to the attention of the public in every possible way, without expense to the Post Office Department, the wonderful network of air lines operating day and night throughout the country, and the speed and economy with which letters and parcels may be dispatched over immense distances through this means of transportation.

On May 15, 1918, the first air mail service was established between New York and Washington. This was the beginning of a system which to-day operates over 9,916 miles of airways and calls for a

daily mileage of mail pilots amounting to 22,110.

POSTAL EMPLOYEES WARNED NOT TO DAMAGE POST-OFFICE EQUIPMENT
