ELECTRIC-LIGHT BULBS

FIRST ASSISTANT POSTMASTER GENERAL, Washington, November 10, 1928.

Attention of postmasters is called to a notice in the POSTAL BULLETIN dated November 3, 1928, under the heading of "Electric-light bulbs," in which it is stated that electric-light bulbs for use in post offices or stations occupying leased quarters, should be obtained on requisition through the Office of the First Assistant Postmaster General, Division of Post Office Quarters and Engineering, and not through the Division of Equipment and Supplies, Office of the Fourth Assistant Postmaster General.

The above notice should be interpreted as applying only to such quarters under lease where "Light" is furnished by the department.

INTERNATIONAL CIVIL AERONAUTICS CONFERENCE STAMP

THIRD ASSISTANT POSTMASTER GENERAL, WASHINGTON, November 10, 1928.

Postmasters and others connected with the postal service are notified that the department is about to issue a new 2-cent and 5-cent commemorative stamp, in connection with the International Civil Aeronautics Conference called by President Coolidge for December 12, 13, 14, 1928, at Washington, D. C.

The new stamps are the same shape and size as the special-delivery stamp, 1^{44}_{100} by 8^{4}_{100} inch. The 2-cent stamp will be printed in red ink and the 5-cent stamp in blue ink. At the top is a dark border panel with wording "U. S. Postage" in white Roman lettering; a small scroll at each end; under the panel in small architectural Roman lettering-" International Civil Aeronautics Conference"; on either side of the stamp are narrow border panels; within the borders are shown on the left the Washington Monument, and the United States Capitol on the right, in the center is a picture of the Wright airplane as first shown by the Wright brothers at Fort Myer, Va. In the lower right and left corners are rectangular shields with numeral 2 in each, a ribbon appears between the numerals and below the areoplane with the dates, December 12, 13, 14, 1928, and under the ribbon a base panel with the word cents in white Roman lettering.

The 5-cent United States postage stamp for the International Civil Aeronautics Conference is similar with the exception of the Wright airplane being replaced by a globe showing the eastern and western continents, and a modern monoplane flying across it; the numerals 5 in place of numerals 2.

The new International Civil Aeronautics Conference stamps will first be placed on sale December 12, 1928, at the Washington, D. C., post office, and for the benefit of stamp collectors and dealers the new stamps will also be placed on sale the same date at the Philatelic Agency, Division of Stamps, Post Office Department.

These stamps will be issued in sheets of 50 and postmasters at central and direct accounting offices desiring a supply may draw requisition for limited quantities on Form 3201, the words "International Civil Aeronautics Conference stamps" to be written plainly on the blank. District postmasters may obtain small quantities of these stamps to meet the local demand by requisition on their central accounting postmasters.
