# IMPORTANT NOTICE

### INCREASED POSTAGE RATES ON LETTERS AND POST CARDS

TO ARGENTINA, BOLIVIA, BRAZIL, CHILE, COLOMBIA, COSTA RICA, CUBA, DOMINICAN REPUBLIC, ECUADOR, GUATEMALA, HAITI, HONDURAS (RE-PUBLIC OF), MEXICO, NICARAGUA, PANAMA, PARAGUAY, PERU, SALVADOR (EL), SPAIN (INCLUDING ANDORRA, BALEARIC ISLANDS, CANARY ISLANDS, AND THE SPANISH POSSESSIONS IN NORTHERN AFRICA), URUGUAY, AND **VENEZUELA** 

> SECOND ASSISTANT POSTMASTER GENERAL, Washington, February 17, 1932.

On and after April 1, 1932, the rates of postage on letters and post cards addressed for delivery in Argentina, Bolivia, Brazil, Chile, Colombia, Costa Rica, Cuba, Dominican Republic, Ecuador, Guatemala, Haiti, Honduras (Republic of), Mexico, Nicaragua, Panama, Paraguay, Peru, Salvador (El), Spain (including Andorra, Alhucemas Island, Balearic Islands, Canary Islands, Ceuta, Chaferinas or Zafarani Islands, Melilla, Penon de Velez de la Gomera and Tangier), Uruguay, and Venezuela will be:

> Letters, for each ounce or fraction\_\_\_\_\_3 cents Post cards (single) 2 cents Post cards (double) 4 cents

In order to be dispatched, letters for the places named must be prepaid one full rate (3 cents), and post cards must be prepaid in full (single 2 cents,

Short-paid letters and post cards inadvertently dispatched, and letters subject to more than one rate but prepaid only 3 cents, upon receipt in the country of destination will be subject to the collection from the addressees of the deficient postage.

It is again announced that, effective September 1, 1931, the postage rates on letters and post cards for Canada and Newfoundland were likewise increased

Letters, for each ounce or fraction 3 cents
Post cards (single) 2 cents
Post cards (double) 4 cents

In order to be dispatched letters for Canada and Newfoundland must also be prepaid one full rate (3 cents), and post cards must be prepaid in full (single 2 cents, double 4 cents). In these cases double the deficiency in postage is collected from the addressees.

Renewed attention is invited also to the fact that (effective September 1, 1931) the rates of postage on letters and post cards to Great Britain, Northern Ireland, and the Irish Free State, and (effective November 1, 1931) to Bahamas, Barbados, Bermuda, British Guiana, British Honduras, Jamaica (including Cayman and Turks and Caicos Islands), Leeward Islands (Anguilla, Antigua, Barbuda, Dominica, Montserrat, Nevis, Redonda, St. Christopher of St. Kitts, and the British Virgin Islands), Netherland (Dutch) West Indies (Aruba, Bonaire, Curacao, Saba, St. Eustatius, and the Dutch part of St. Martins), New Zealand (including Cook Islands, British Samoa, and Danger (Pukapuka), Manihiki, Palmerston (Avarua), Penrhyn (Tongareva) Rakaanga, Savage (Niue), and Suwarrow Islands), Trinidad (including Tobago), and Windward Islands (Grenada, the Grenadines, St. Lucia, and St. Vincent), are:

Letters, for the first ounce or fraction \_\_\_\_\_\_\_\_ 5 cents
Letters, for each additional ounce or fraction \_\_\_\_\_\_\_\_ 3 cents
Post cards (single) \_\_\_\_\_\_\_\_ 3 cents
Post cards (double) \_\_\_\_\_\_\_\_ 6 cents

In these cases double the deficiency in postage is collected from addressees. It is to be noted that, on and after April 1, 1932, there will be no 2-cent letter rate and no 1-cent post card rate from the United States to any foreign

With respect to the payment of postage on correspondence addressed to foreign countries, the importance of prepaying postage in full is particularly stressed, since articles on which the postage has not been prepaid, or has not been fully prepaid, represent postal revenue which should be collected by the post office of mailing in this country, and when dispatched are subject to special treatment which necessarily involves more or less delay, in some cases sufficient to miss an intended steamship dispatch. Furthermore, as the deficiency in postage or double the deficiency, as the case may be, is collected on delivery, unpaid or short paid articles may be refused by addressees or, if accepted, may create an unfavorable impression, resulting in the loss of business or misunderstanding between correspondents.

# **INCREASED POSTAGE RATES**

ON PRINTED MATTER, SAMPLES OF MERCHANDISE, COMMERCIAL PAPERS, AND 8-OUNCE MERCHANDISE PACKAGES FOR FOREIGN COUNTRIES

Effective April 1, 1932, the rates of postage applicable to the undermentioned articles, mailed in the United States and addressed for delivery in foreign countries, will be as follows:

Printed matter (including second-class matter, except when mailed by publishers or registered news agents to Canada, Newfoundland, and Pan American countries, including Spain), 11/2 cents (instead of 1 cent) for each

2 ounces or fraction of 2 ounces. Second-class matter, mailed by publishers or registered news agents to Argentina, Bolivia, Brazil, Chile, Colombia, Costa Rica, Cuba, Dominican Republic, Ecuador, El Salvador, Guatemala, Haiti, Republic of Honduras, Mexico, Nicaragua, Panama, Paraguay, Peru, Spain (including Andorra, Alhucemas Island, Balearic Islands, Canary Islands, Ceuta, Chaferinas or Zafarani Islands, Melilla, Penon de Velez de la Gomera and Tangier), Uruguay, and Venezuela, 2 cents per pound or fraction thereof on the por-

tion of such publications devoted to matter other than advertisements, 10 cents per pound on the portion of such publications devoted to advertisements, except in the case of publications maintained by and in the interests of religious, educational. scientific, philanthropic, agricultural, labor, or fraternal organizations or associations not organized for profit and none of the net income of which inures to the benefit of any private stockholder or individual, on which the rate shall be 2 cents a pound or fraction thereof.

The rate of 2 cents a pound or fraction thereof on the portion devoted to other than advertisements, and 10 cents a pound or fraction thereof on the portion devoted to advertisements shall apply to daily newspapers, issued as frequently as six times a week addressed to bona fide subscribers in Canada and Newfoundland; provided that on all other second-class publications addressed for delivery in Canada and Newfoundland the rate of postage shall be 1 cent for each 4 ounces or fraction of 4 ounces, calculated on the weight of each package and prepaid by postage stamps affixed, and copies of such publications addressed for delivery from the same post office may be placed in one package, addressed to such post office, and postage paid thereon by affixing the stamps to the outside wrapper.

Samples of merchandise.—1½ cents (instead of 1 cent) for each 2 ounces or fraction of 2 ounces, with a minimum charge of 3 cents (instead of

Commercial papers.—1½ cents (instead of 1 cent) for each 2 ounces or fraction of 2 ounces, with a minimum charge of 5 cents.

Eight-ounce merchandise packages for Argentina, Bolivia, Brazil, Canada. Chile, Colombia, Costa Rica, Cuba, Dominican Republic, Ecuador, Guatemala, Haiti, Honduras (Republic of), Mexico, Newfoundland, Nicaragua, Panama, Paraguay, Peru, Salvador (El), Spain (including Andorra, Alhucemas Island, Balearic Islands, Canary Islands, Ceuta, Chaferinas, or Zafarani Islands, Melilla, Penon de Velez de la Gomera, and Tangier), Uruguay, and Venezuela, 1½ cents (instead of 1 cent) for each 2 ounces or fraction of 2 ounces, when the contents consist of seed, scions, plants, cuttings, bulbs, and roots; 2 cents (instead of 1½ cents) for each 2 ounces or fraction of 2 ounces for other 8-ounce merchandise packages.

All classes of printed matter, as well as samples of merchandise, commercial papers, and 8-ounce merchandise packages, for foreign countries must be fully prepaid before dispatch.

Any article, regardless of its class, not sufficiently prepaid to authorize its dispatch must be returned to the sender unless the name and address of the sender is not known, when it must be sent to the Division of Dead Letters for appropriate disposal.

Postmasters are urged to see to it that the employees of their offices are thoroughly familiar with the foregoing rates, and requested to utilize every facility available, without expense to the department, for informing their patrons concerning said rates.

The department was much pleased to note reports received of the splendid efforts made by certain postmasters to give publicity to the increased rates on letters and post cards for certain foreign countries which became effective in September and November last, and which are referred to above.

For obvious reasons, it may be considered to be the wish of every mailer fully to prepay his correspondence of whatever class if he is able to do so through information as to proper rate, and it is the earnest wish of the department to utilize every practicable facility for making such information readily available. To this end the fullest cooperation of postmasters and their employees is expected.

# PARCEL-POST SERVICE TO BRITISH CAMEROONS

SECOND ASSISTANT POSTMASTER GENERAL, Washington, February 19, 1932.

Effective at once, parcel-post packages addressed for delivery in British Cameroons are subject to the following transit charges, in addition to the postage rate of 14 cents a pound or fraction thereof:

1 to 3 pounds	\$0.60
4 to 7 pounds	. 84
8 to 11 pounds	1. 20
12 to 22 pounds	1. 80

Both postage rates and transit charges must be prepaid at time of mailing. The above transit charges supersede those now shown in the table appearing under the item "British Cameroons—Parcel Post," on page 292 of the current Official Postal Guide.

# INTERNATIONAL MONEY ORDERS DRAWN ON FRANCE MUST NOT BE HANDED TO REMITTER

THIRD ASSISTANT POSTMASTER GENERAL,

Washington, February 19, 1932. On February 1, 1932, a new money order convention went into effect between the United States and France. By the terms of this new convention payment is not to be made on the original order but on an order reissued by the country of payment.

In the Postal Bulletin of January 21, 1932, this fact was fully set forth and postmasters were expressly cautioned not to deliver the original

order to the remitter.

Nevertheless so many instances have been reported to this department where the original order is still being handed to the purchaser that it is deemed proper to warn all international money order offices, branches, and stations that it may become necessary to hold the issuing clerk financially responsible in the event of double payment if it be found impossible to recover the amount from the payee.

## SHORT-PAID SPECIAL-HANDLING AND SPECIAL-DELIVERY PARCELS

THIRD ASSISTANT POSTMASTER GENERAL, Washington, February 17, 1932.

With reference to paragraph 4, section 835, Postal Laws and Regulations, as amended by order No. 2127 of January 23, 1932, postmasters are advised that while the procedure therein prescribed is the one ordinarily to be followed in cases of short-paid matter of the second, third, and fourth classes, nevertheless, when through inadvertence a parcel of fourth-class matter prepared for mailing as special-handling or as special-delivery matter is partly but not fully prepaid, and it is not practicable to collect the deficiency from the sender without delaying the parcel, it should be rated with the amount due and dispatched, the deficiency to be collected upon delivery, as set forth in the instructions on page 12 of the September, 1931, Supplement to the Postal Guide.

In such case, however, the sender should be advised that it is expected that the full postage, together with the proper special handling or special

delivery charge, will be prepaid on parcels mailed in future.
