CHANGES FOR THE FOREIGN AIR-MAIL SERVICE LEAFLET

In consequence of the changes in the air-mail service from London and

from Hong Kong, the following changes should be made in Part 3 of the Foreign Air Mail Service leaflet.

In each of the following items, in the transit time "From London", add the words "(1 day later in winter)": Anglo-Egyptian Sudan, Bahrein, Borneo (North), Brunei, Burma, China, Egypt, Federated Malay States, French Equatorial Africa, Gold Coast Colony, Hong Kong, India (British), Iraq, Kenya, Malay States (Nonfederated), Nigeria, Northern Rhodesia, Nyasaland, Palestine, Portuguese East Africa, Sarawak, Siam, Southern Rhodesia, Southwest Africa, Straits Settlements, Syria, Tanganyika Terr., Transjordan, Uganda, Union of South Africa, and Zanzibar.

In the items New Guinea and Papua, add after "Lv. London Sunday" the words "(Saturday in winter);" and in the following lines add after "12 days" and "11 days" the words "(13 days in winter)" and "(12 days in winter)," respectively.

In the item Burma, in the third line of the Trans-Pacific routing, add after "11 days" the words "(10 days in winter)."

In the item India (British), at the end of the Trans-Pacific routing, add

"(In winter, 10 days to Calcutta and 11 days to Karachi).

In the items Federated Malay States, Nonfederated Malay States, and Straits Settlements, in the third line of the Trans-Pacific routing, add after "13 days" the words "(14 days in winter)."

NEW ISSUE OF 16-CENT ORDINARY POSTAGE STAMPS

Postmasters are hereby advised that the 16-cent stamp bearing the likeness of Abraham Lincoln will be the next denomination to be made available in the new regular series.

The stamp will conform in general design to the preceding denominations of this series having single-line borders. It will be printed in black by the rotary process and issued in sheets of 100.

The new 16-cent stamp will be first placed on sale at Washington, D. C., on October 20, 1938, and at other post offices as soon thereafter as practicable. Stamp collectors desiring first-day cancelations of the new stamp on October 20 may send a limited number of addressed covers, not in excess of 10, to the Postmaster, Washington, D. C., with a cash or postal money order remittance to cover only the cost of the stamps required for affixing. Postage stamps will positively not be accepted in payment. Each cover should bear a pencil endorsement in the upper right corner to show the number of stamps to be attached thereto. Envelopes for covers should not be smaller than 3 by 6 inches. Compliance cannot be made with unusual requests, such as for the affixing of plate number blocks, etc., and all covers must be fully addressed.

Requests for uncanceled stamps must not be included with orders for

first-day covers to the postmaster at the above office.

For the benefit of collectors desiring stamps of selected quality for philatelic use, the new 16-cent stamp will be placed on sale at the Philatelic Agency, Washington, D. C., on October 20, 1938. To insure prompt shipment, mail orders to the Agency by matter than the provided to the 16-cent stamp, excluding other varieties of stamps heretofore on sale.

Postmasters at direct and central-accounting post offices may submit separate requisitions for a limited supply of the new issue 16-cent stamps to conform to local mailing requirements, but such requisitions must exclude

higher denominations not yet issued. So far as manufacturing conditions will permit, all regular requisitions for 16-cent stamps after October 20 will be filled in whole or in part with

stamps of the new issue.

So far as required to meet specific requests from local patrons, postmasters at district-accounting offices may obtain needed stocks of new design 16-cent stamps by requisition on the central-accounting postmaster after October 20. In some cases shipments of the new 16-cent stamp may be received by postmasters prior to the close of business on October 20. In all such cases care must be exercised not to allow any of the stamps to be sold before October 21.

AIR-MAIL STAMPS

The attention of postmasters is called to the list of available denominations of air-mail stamps in paragraph 2, page 43 of the Official Postal Guide, which includes the following values: 6, 10, 15, 20, and 50 cents; also 16-cent (air-mail special delivery). Requisitions to the Department must be restricted to these denominations.

Contrary to the above instructions, requisitions in large numbers are still being submitted to the Department for 25-cent air mail stamps (Trans-Pacific), the distribution of which was discontinued at the time the postage

rate was reduced in February 1937.

Postmasters at all direct and central-accounting post offices are requested to refrain from submitting further requisitions for 25-cent air-mail stamps. The 20-cent air-mail stamp is available in regular issue as well as in the special Trans-Pacific design. Requisitions for 20-cent air-mail stamps will, hereafter, be filled with regular issue air-mail stamps unless endorsed

"Trans-Pacific."

On receipt of this notice, the postmaster will carefully examine his records to ascertain whether any of these forms have already been paid at his office. If the coupon of any such order is found in the paid files or if any of the forms are hereafter presented for payment he should promptly report that fact to the post-office inspector in charge of his division. A postmaster should take similar action in case of theft of forms from his office, being careful to give the correct serial numbers, and under no circumstances to issue orders on such forms in event of their recovery.

POSTAGE STAMP STOCK FOR HOLIDAY MAILINGS

The attention of postmasters is again called to the necessity of making provision in advance for the larger quantities of postage stamps and other stamped paper required for sale during the holiday season, in order that shipments to post offices may be completed before the mails become congested. To facilitate the distribution, postmasters are requested to submit requi-

sitions as follows:

First-class post offices.—Postmasters at offices of the first class should submit an initial requisition as promptly as possible after October 1 for the quantities of 1-, 1½-, 2-, and 3-cent stamps needed for current use together with the quantities of stamps above the 3-cent denomination needed for sale until the regular quarterly requisition is submitted after January 1. A second requisition should then be submitted between November 1 and 15, for the additional quantities of stamps in denominations of 1 cent to 3 cents, inclusive, needed for sale until the next quarterly requisition is submitted after January 1.

Second-class post offices.—Postmasters at offices of the second class should include in one requisition not later than November 1 the full quantities of stamp stock needed for sale throughout the December quarter, with due allowance for the heavier holiday mailings. These requisitions will be filled as promptly as possible in the order of their receipt.

District post offices.—Postmasters at district-accounting post offices are directed to forward stamp requisitions and all available postal cash to the central-accounting office in the designated periods of November to restore the fixed credit in stamp supplies to the full amount. At those district post offices where sufficient stamps cannot thus be provided to meet the requirements until the January requisition is submitted, the postmasters may submit requisitions for additional supplies to reach the central-accounting office not later than December 10. Postmasters at district post offices are directed to withhold all stamp requisitions to the central-accounting office from December 10 to December 28, except in cases of extreme and unavoidable emergency. In unusual cases, the central-accounting postmaster may furnish a district postmaster, upon request, with additional needed stamp stock in November on a temporary fixed credit receipt to be canceled not later than December 31 by the return of stock or cash.

Careful compliance with the above instructions by all postmasters will enable the Department to regulate the production and complete the distribution prior to the holiday period.

Postmasters should not, however, submit requisitions for stamp stock in excess of available storage space or in amounts that cannot be given adequate protection. (See secs. 106 and 121, Postal Laws and Regulations.)
