ORDERS OF THE POSTMASTER GENERAL

RESTRICTIONS ON PARCELS TO PERSONNEL OF THE U. S. NAVY, MARINE CORPS AND COAST GUARD OVERSEAS

ORDER No. 19857; DATED JANUARY 26, 1943.

The Navy Department has informed the Post Office Department that because shipping space is so sorely needed for ammunition, food and medical supplies, it is not possible to increase the cargo space used for mail as the number of men in the naval service at sea and overseas expands.

Therefore, in accordance with the recommendation of the Navy Department, to assure prompt service without demanding increased cargo space, effective from January 15, 1943:

No parcel shall be accepted for mailing to personnel of the U. S. Navy, Marine Corps, or Coast Guard who are stationed overseas if it weighs more than 5 pounds, or exceeds 15 inches in length, or 36 inches in length and girth combined. This includes parcels addressed in care of the Postmaster at New York, N. Y., or San Francisco, Calif. For the present, it is not necessary that an approved request be obtained from the addressee before parcels may be mailed to naval personnel overseas but not more than one parcel within these limits of weight and size shall be accepted for mailing in any one week when sent by or on behalf of the same person or concern to or for the same addressee. No perishable matter shall be accepted for such personnel.

Except as above indicated, the conditions heretofore applicable to mail for personnel of the Navy, Marine Corps, and Coast Guard overseas shall continue in effect.

In connection with the foregoing the Navy Department has pointed out that the Army and Navy are working together to encourage the use of V-mail as a means of improving the mail service and reduce cargo requirements for mail. V-mail affords fast, safe mail service and represents a saving of 98 percent in cargo space compared to ordinary mail.

CHANGE—POSTAL GUIDE, 1941, PART I FILES AND RECORDS

ORDER No. 19835; DATED JANUARY 21, 1943.

Order No. 18149, appearing as Change No. 27 on pages 53 to 75, inclusive, of the July 1942 Supplement to the Postal Guide, is amended by adding the following note after the third paragraph of the instructions under the caption "Files and Records" on page 53:

Note.—The periods for which records covering domestic registered, insured and c. o. d. mail shall be retained, mentioned on pages 67 and 69 of this supplement, are the periods for which the records usually should be retained. However, as a wartime measure to permit the proper handling of inquiries and claims covering such matter, all records (initial, intermediate, transit and final), relating to domestic registered, insured and c. o. d. matter mailed on and after July 1, 1939, shall be retained indefinitely, unless otherwise authorized in any particular instance by the Department.

AMENDMENT TO THE POSTAL LAWS AND REGULATIONS Report of Nonreceipt of Pouches

ORDER No. 19836; DATED JANUARY 21, 1943.

Paragraph 1, section 753, Postal Laws and Regulations, is amended to read as follows:

"When a pouch is received addressed to another office or railway post office, and, on account of being delayed, is opened and the contents distributed in order to advance the mail, the label of such pouch shall be marked 'Distributed,' postmarked, and sent direct to the office of destination, if addressed to a post office, or to the chief clerk (if known, otherwise to the superintendent) of the railway post-office line addressed, so that the pouch may be properly accounted for. Unless there is reason to think the pouch has been lost or stolen, the postmaster may defer reporting nonreceipt of pouch for 12 hours after pouch is due, or until arrival of next following mail; then if label is received, no report need be made." In the case of an air mail pouch, however, report of nonreceipt need not be made until sufficient time has elapsed for the label or the pouch to have reached the office of address by surface mail.

AMENDMENT TO THE POSTAL LAWS AND REGULATIONS MAIL MESSENGER SERVICE

Limitation of Pay-Dual Employment

ORDER No. 19856; DATED JANUARY 26, 1943.

Section 1772, paragraph 2, Postal Laws and Regulations of 1940, as amended, is hereby further amended to read as follows:

2. Post-office employees at post offices of all classes not named in the preceding paragraph may also, in the discretion of the Postmaster General, enter into contracts for the performance of mail-messenger service, provided the total amount paid under such contract shall not exceed \$300 in any one . . . year, except that special-delivery carriers may receive in excess of \$300 for mail-messenger service in any one . . . year . . .

INSTRUCTIONS OF SECOND ASSISTANT POSTMASTER GENERAL

IMPORTANT

Matches of Every Description Prohibited in International Mails as Well as in Domestic Mails Requiring Sea Transportation

Notwithstanding previous announcements on the subject (see the Postal Bulletins of May 20, 1941, April 20, 1942, and August 24, 1942) reports continue to be received indicating that matches are still being sent in the mails to foreign countries and to other overseas destinations.

Particular attention is called to the fact that matches are not only prohibited transmission in the mails to all foreign countries, including Canada and Mexico, but also when addressed to any United States domestic destination where sea transit is involved, whether for civilians or members of our armed forces.

Postmasters will cause special notice of the foregoing to be taken at their offices. In all cases where cigarettes are presented for mailing to destinations outside of the continental United States specific inquiry shall be made of the sender by the accepting clerk as to whether matches of any description are included in the package.

It is requested that the widest possible publicity, without expense to the Department, be given to the foregoing.

On receipt of this notice the postmaster will carefully examine his records to ascertain whether any of these forms have already been paid at his office, and if the coupon of any such order is found, he should promptly report that fact to the post-office inspector in charge of his division. If any person should present one of the orders for payment, he should be detained for questioning, if possible, and the post-office inspector and local officers summoned. If the offender flees, the postal employee should record the description of the fugitive and of any accomplice, together with the number of State license and make of car, if one is used. The information secured should be telegraphed or telphoned (Government-rate collect) to the inspector in charge if an inspector is not available.

A postmaster should also telegraph or telephone the inspector in charge in case of theft of forms from his office, being careful to give the correct serial numbers, and under no circumstances to issue orders on such forms in event of their recovery.
