#### ORDERS OF THE POSTMASTER GENERAL

FURTHER EXTENSION OF RESTRICTED MAIL SERVICE TO FRANCE ORDER No. 26164; DATED OCTOBER 9, 1944.

Effective October 10, 1944, limited mail service (restricted to unregistered, nonillustrated post cards in English or French, on personal or family matters) is extended to the whole of continental France, excluding the territory of Belfort, and the departments of Charente-Inferieure, Doubs, Loire-Inferieure, Meurthe-et-Moselle, Meuse, Morbihan, Moselle, Bas-Rhin, Haut-Rhin, Haute-Saone, Vosges, Basses Pyrenees, Landes, and Gironde.

Effective October 15, 1944; this service will be further extended to the departments of Basses Pyrenees, Landes, and Gironde.

The postage rate applicable to these cards is 3 cents each.

Order No. 25851, dated September 4, 1944, and subsequent related orders are modified accordingly.

## AMENDMENTS TO THE POSTAL LAWS AND REGULATIONS

ORDER No. 26165; DATED OCTOBER 9, 1944. INSERT No. 280.

#### DEFINING THE WORD BOOK

Paragraph 6 of section 572, Postal Laws and Regulations of 1940, as amended, is further amended to read as follows:

"6. A book, within the contemplation of paragraph 5, shall be a volume permanently bound in cloth or paper having 24 or more pages, of which at least 22 are printed, and with the exception of text books containing incidental spaces for students' notations, shall not contain ruled or blank pages intended for records or memoranda purposes."

#### RATES ON SPECIAL DELIVERY MATTER

ORDER No. 26166; DATED OCTOBER 9, 1944. Insert No. 281.

Effective November 1, 1944, paragraph 1, section 1077, Postal Laws and Regulations of 1940, is amended to read as follows:

"1077. To procure the most expeditious handling and transportation practicable and the immediate delivery of mail matter at the office of address, special-delivery stamps shall be affixed thereto, in addition to the regular postage, in accordance with the following schedule: Matter weighing not more than 2 pounds, if of the first class, . . . . 13 cents, if of any other class, . . . . 17 cents; matter weighing more than 2 but not more than 10 pounds, if of the first class, 20 cents, if of any other class, 25 cents; matter weighing more than 10 pounds, if of the first class, 25 cents, if of any other class, 35 cents: Provided, That under such regulations as the Postmaster General may prescribe, ordinary postage stamps of equivalent value may be accepted in lieu of the special-delivery stamps herein specified" (Public Law 424, approved September 17, 1944).

Note.—See section 132 as to distinctive stamps for special delivery.

## FEES FOR REGISTRY RETURN RECEIPTS

ORDER No. 26167; DATED OCTOBER 9, 1944. Insert No. 282.

Effective November 1, 1944, paragraph 1 (c), section 1218, Postal Laws and Regulations of 1940, is amended to read as follows:

"(c) The fees for obtaining receipts for registered mail . . . . shall ... be increased by 33\% per centum, computed ..., if the amount of such increase is not a multiple of 1 cent, to a multiple of 1 cent next above such amount" (act of . . . . September 17, 1944, Public . . . **424**, effective . . . . November 1, 1944).

## NEW FEES FOR REGISTERED C. O. D. MAIL

ORDER No. 26168; DATED OCTOBER 9, 1944. Insert No. 283.

Effective November 1, 1944, section 1383, Postal Laws and Regulations of 1940, is amended as follows:

The note following paragraph 1 is amended to read as follows:

Note.—See section 1385, paragraph 3, citing the law authorizing the Postmaster General to extend the collect-on-delivery service to sealed domestic mail of any class bearing postage at the first-class rate . . . . . "

Paragraphs 4 and 5 (a), are combined and amended to read as follows:

"4. The . . . . fees for collect-on-delivery service for registered sealed domestic mail of any class bearing postage at the first-class rate and the limits of indemnity . . . . for the loss, rifling, or damage thereof in the receipt requested subsequent to the time of mailing, 7 cents; and for return

mails, shall, in addition to . . . . postage . . . . and any other required additional fees, be as follows:

(Act of September 17, 1944, Public Law 424, effective November 1, 1944.) Paragraph 5 (b) is designated as paragraph 5, and amended to read as follows:

"(b) Surcharges shall be collected on registered collect-on-delivery mail under the same conditions as are outlined for the regular registered mail (see sec. 1203) except that in determining the amount of surcharge collectible, there shall be taken as a basis the amount by which the declared actual value of the article mailed exceeds the limits of indemnity payable for the fees prescribed for registered collect-on-delivery mail in paragraph 4 . . . . of this section."

Effective November 1, 1944, the note following paragraph 3, section 1385, Postal Laws and Regulations of 1940, is amended by the addition of a paragraph reading as follows:

"See amended paragraph 4, section 1383, quoting the act of September 17, 1944, fixing the fees and limits of indemnity for registered collect-ondelivery mail."

## **NEW INSURANCE FEES**

ORDER No. 26169; DATED OCTOBER 9, 1944.

Insert No. 284.

Effective November 1, 1944, paragraphs 4 and 5, section 1386, Postal Laws and Regulations of 1940, as amended, are further amended as follows: Subparagraph (a) of paragraph 4 is amended to read as follows:

"(a) The fee for insurance shall be . . . . 3 cents for indemnification not to exceed \$5, 10 cents for indemnification not to exceed \$25, 15 cents for indemnification not to exceed \$50, and 25 cents for indemnification not to exceed . . . . **\$200 . . . . \* \* \*** " (act of September 17, 1944, Public Law 424, effective November 1, 1944).

Note (c) and subparagraphs (aa) and (aaa) of paragraph 4 are rescinded. Subparagraph (a) of paragraph 5 is amended to read as follows:

"(a) \* \* \* Whenever the sender of an insured article of mail matter shall so request, and upon payment of a fee of . . . . 4 cents at the time of mailing, or of . . . . 7 cents subsequent to the time of mailing, a receipt shall be obtained for such insured mail matter, showing to whom and when the same was delivered, which receipt shall be returned to the sender and be received in the courts as prima facie evidence of such delivery: provided . . . . , That upon payment of the additional sum of . . . . 27 cents at the time of mailing by the sender of an insured article of mail matter, a receipt shall be obtained for such insured mail matter, showing to whom, when, and the address where the same was delivered, which receipt shall be returned to the sender, and be received in the courts as prima facie evidence of such delivery: Provided further, That no refund shall be made of fees paid for return receipts for registered or insured mail where the failure to furnish the sender a return receipt or the equivalent is not due to the fault of the Postal Service" (act of September 17, 1944, Public Law 424, effective November 1, 1944).

Subparagraph (aa) of paragraph 5 is rescinded.

Subparagraph (aaa) of paragraph 5 is designated as subparagraph (aa) of paragraph 5, and amended to read as follows:

"(aa) Effective March 26, 1944, the fee for a sender's return receipt for insured mail requested at the time of mailing shall be 4 cents; for return

receipt showing to whom, when and the address where the article was delivered, 31 cents." (See act of February 25, 1944, Public Law 235, effective March 26, 1944; also see act of September 17, 1944, Public Law 424, effective November 1, 1944.)

NEW C. O. D. FEES, AND NEW FEE FOR DELIVERY UPON CHANGED TERMS ORDER No. 26170; DATED OCTOBER 9, 1944. INSERT No. 285.

Effective November 1, 1944, paragraphs 1 and 12, section 1387, Postal Laws and Regulations of 1940, as amended, are further amended as follows: Subparagraph (b) of paragraph 1 and the note following are amended to read as follows:

"(b) The fee for collect-on-delivery service for domestic third- and fourth-class mail shall be 15 cents for collections and indemnity not to exceed \$2.50; .... 20 cents for collections and indemnity not to exceed \$5; . . . . 30 cents for collections and indemnity not to exceed \$25; . . . . 40 cents for collections and indemnity not to exceed \$50; . . . . 50 cents for collections and indemnity not to exceed \$100; . . . 55 cents for collections and indemnity not to exceed \$150; and . . . . 60 cents for collections and indemnity not exceeding \$200. \* \* \* The fees for collect-on-delivery service for sealed domestic mail matter of any class bearing postage at the first-class rate shall be equal in each case to the fee charged for collect-on-delivery service for domestic thirdand fourth-class mail" (act of September 17, 1944, Public Law 424, effective November 1, 1944).

"Note.— . . . . See section 1383 relative to collect-on-delivery service for registered mail of any class sealed against postal inspection and prepaid at the first-class rate of postage."

Subparagraphs (bb) and (bbb) of paragraph 1 are rescinded.

Subparagraph (aa) of paragraph 12 is rescinded.

Subparagraph (b) of paragraph 12, as amended, is further amended to read as follows:

"(b) If sender directs, the amount originally stated as due on delivery of a collect-on-delivery article may be increased (not to exceed \$200, the maximum amount collectible), decreased, or canceled, or the article may be delivered at the office where held to other than the original addressee. Such direction shall be filed with the postmaster at the office of mailing, who shall connect the authorization with the mailing-office record of the article and immediately notify the postmaster at the office where the article is held. The fee of . . . . 10 cents for this service shall be collected from the sender and affixed by the postmaster at the office of mailing by means of uncanceled postage stamps to Form 3818 or other communication used for this purpose, and canceled." (See act of September 17, 1944, Public Law 424, effective November 1, 1944.)

## DECREASED DEMURRAGE CHARGE, AND FEE FOR NOTIFYING SENDER OF **NONDELIVERY**

ORDER No. 26171; DATED OCTOBER 9, 1944. INSERT No. 286.

Effective November 1, 1944, section 1388, Postal Laws and Regulations of 1940, as amended, is further amended as follows:

"Subparagraph (b) of paragraph 1, is rescinded, and paragraph 1 (a) is designated as paragraph 1."

Paragraph 2, as amended, is further amended to read as follows:

"2. A demurrage charge of . . . . 5 cents per day shall be collected on each domestic c.o.d.article (registered or unregistered) which the addressee fails to remove from the post office within 20 days after the first attempt to deliver or the first notice of arrival at the office of address, exclusive of the day delivery is first attempted or the first notice of arrival is issued at the office of address, the actual day of delivery, Sundays and holidays. No demurrage shall be charged on c. o. d. articles exchanged between the United States proper and Hawaii, Alaska, Puerto Rico, Virgin Islands of the United States, Guam, and Tutuila, Samoa." (See act of September 17, 1944, Public Law 424, effective November 1, 1944.)

A new paragraph 4 is inserted to read as follows:

"4. \* \* \* The fee for notifying the sender or his representative of inability to deliver a collect-on-delivery article shall be 5 cents" (act of September 17, 1944, Public Law 424, effective November 1, 1944).

Present paragraph 4 of section 1388, as amended, is further amended to become paragraph 5, and to read as follows:

"5. . . . . The sender or his representative shall be notified of nondelivery only when collect-on-delivery mail is endorsed to show that . . . . notice is desired. Notice is to be sent . . . as soon as it is definitely known that . . . . a collect-on-delivery article is . . . . undelivered, but, in any event, within 5 days after the date of receipt of the article at the office of address. The fee for this service shall be collected by the postmaster at the office where the sender or his representative is located by means of postage-due stamps affixed to the notice. . . . . The date on

which notice is sent to the sender or his representative of undelivered collecton-delivery mail shall be entered in the space provided for that purpose on the c. o. d. tag. No other record shall be made of the issuance of such notice nor shall the . . . . mail be so endorsed."

## REDUCTION OF MONEY ORDER, INSURANCE AND C. O. D. FEES INCREASE OF MINIMUM SPECIAL DELIVERY FEES **EFFECTIVE NOVEMBER 1, 1944**

The act of September 17, 1944 (Public No. 424, 78th Cong.), restores the money-order fees which were in effect prior to March 26, 1944, and decreases the fees for insured and c. o. d. mail and makes other changes in the charges applicable to c. o. d. mail. The act increases the fees for special delivery service for all classes of mail weighing up to 2 pounds.

These changes become effective November 1, 1944, and should be given the widest publicity possible without expense to the Department.

The prepayment of the foregoing fees on second-, third-, or fourth-class mail entitles it to the most expeditious handling and transportation practicable, and also entitles it to special delivery at the office of address.

#### **NEW 13-CENT AND 17-CENT SPECIAL DELIVERY STAMPS**

Postmasters and employees of the Postal Service are advised of the issuance of two special-delivery stamps, in 13-cent and 17-cent denominations, to meet the increased special delivery fees which will become effective November 1, 1944.

The 13-cent and 17-cent special-delivery stamps will be identical in size, arrangement, and design with the current 10-cent and 15-cent specialdelivery stamps, the only alterations being the change in the denomination numerals. The 13-cent stamp will be printed in blue, and the 17-cent in orange, in sheets of 50. These stamps will be first placed on sale at the Washington, D. C., post office on October 30, 1944.

Stamp collectors desiring first-day cancelations of the 13-cent and 17cent special-delivery stamps on October 30, may send envelopes, properly addressed and having regular postage affixed, to the Postmaster, Washington 13, D. C., with cash or money-order remittance to cover cost of the new special-delivery stamps to be added. As the service in the Washington post office will be limited to the affixing of the new special-delivery stamps, all covers submitted must have postage at the first-class rate already affixed. Special-delivery stamps themselves are not valid for the prepayment of postage. When addressing envelopes, sufficient space must be allowed for the stamps and postmark. An enclosure of medium weight should be placed in each envelope, and the flap either turned in or sealed. Postage stamps and personal checks will not be accepted in payment for stamps.

Requests for uncanceled stamps must not be included with orders for first-day covers. For collections, quality selections of the new stamps may be obtained on mail orders addressed to the Philatelic Agency, Washington 25, D. C. The Agency does not service first-day covers.

Postmasters at direct- and central-accounting offices will receive an initial stock of these 13-cent and 17-cent special-delivery stamps on orders prepared in the Department. The usual requisitions should be submitted later as additional supplies of these stamps are required. Postmasters at district-accounting offices may obtain immediate supplies of the 13-cent and 17-cent special-delivery stamps by requisition on the central-accounting office.

Postmasters at direct- and central-accounting offices may include unsold 10-cent and 15-cent special-delivery stamps in their next regular shipment of redemption stock to the Department. District-accounting postmasters may return unsold 10-cent and 15-cent special-delivery stamps to the central-accounting office in exchange for other stamp stock.
