

## ORDERS OF THE POSTMASTER GENERAL

### RELIEF PARCELS FOR CHINA

ORDER No. 39792; DATED FEBRUARY 3, 1949.

Effective at once, parcels accepted for mailing to China as "U. S. A. gift parcels" in accordance with Order No. 39454 must not contain any articles other than nonperishable food, clothing, including shoes, and mailable medical and health supplies, not exceeding \$50 in value. These limitations are imposed in accordance with agreement made between the Economic Cooperation Administration and the Chinese authorities.

The foregoing supersedes the third paragraph of Order No. 37824, dated June 26, 1948, published in the *POSTAL BULLETIN* of June 29, 1948, insofar as concerns the items which may be included in U. S. A. gift parcels addressed to China; however, such parcels must still conform with the fourth paragraph of the order which requires that the combined total domestic retail value of all butter, and other edible fats and oils included in each parcel must not exceed \$5, and that the combined total domestic retail value of all streptomycin, quinine sulfate, and quinine hydrochloride included in each parcel also may not exceed \$5.

### RELIEF PARCELS FOR GREAT BRITAIN AND NORTHERN IRELAND

ORDER No. 39813; DATED FEBRUARY 4, 1949.

Effective at once, parcels accepted for mailing to Great Britain and Northern Ireland as "U. S. A. gift parcels" in accordance with Order No. 39240 must not contain any articles other than nonperishable food, discarded wearing apparel, mailable medical supplies, and soap. These limitations are imposed in accordance with agreement made between the Economic Cooperation Administration and the British authorities.

The foregoing supersedes the third paragraph of Order No. 37824, dated June 26, 1948, published in the *POSTAL BULLETIN* of June 29, 1948, insofar as concerns the items which may be included in U. S. A. gift parcels addressed to Great Britain and Northern Ireland; however, such parcels must still conform with the fourth paragraph of the order which requires that the combined total domestic retail value of all soap, butter, and other edible fats and oils included in each parcel must not exceed \$5, and that the combined total domestic retail value of all streptomycin, quinine sulfate, and quinine hydrochloride included in each parcel also may not exceed \$5.

## INSTRUCTIONS OF FIRST, SECOND, AND THIRD ASSISTANT POSTMASTERS GENERAL

### SALE OF 6-CENT AIR MAIL STAMPS IN BOOKS

In the *POSTAL BULLETIN* for January 25, 1949, there appeared instructions of the Third Assistant Postmaster General quoted in part as follows:

"The Department has a supply of 12—6-cent air-mail stamp books on hand and any postmaster having a demand for them should submit a requisition for a stock adequate to meet the demands of his office. Any office having a supply of these stamp books on hand in their stamp stock, should immediately make them available at all stamp windows."

Postmasters at air stop points are requested to give publicity to the availability of the 6-cent air mail stamps in books and to encourage the sale of the 6-cent air mail stamp books. It is suggested that an attractive notice informing the public that air mail stamps, in books, are available, be prepared and posted in the lobby, preferably at or adjacent to stamp windows.

## INSTRUCTIONS OF FIRST AND THIRD ASSISTANT POSTMASTERS GENERAL

### DISTRIBUTION OF NEW FORM 22-S AND REVISED FORM 22

An emergency printing will be made by the postmaster at Chicago, Ill., of new Form 22-S, Notice to Publisher of Change of Address, and revised Form 22, Order to Change Address. As rapidly after printing as practicable, these forms will be distributed to each first- and second-class post office. Further distribution to third- and fourth-class offices will be made by the regular supply office upon receipt of the shipment from Chicago. The initial supply should be sufficient to operate for several months pending receipt of the regular stock.

Detailed instructions relative to the use of the new forms will be published at an early date. Under no circumstances should the forms be used pending publication of these instructions.

### SALE OF UNDELIVERABLE C. O. D. BABY CHICK SHIPMENTS

It has come to the attention of the Department that numerous postmasters are failing to comply with the provisions of section 804, paragraph 7 of the Postal Laws and Regulations, which require postmasters to submit certain information to the postmaster at the office of mailing or address, as may be appropriate, or both, if the matter is disposed of in transit in connection with sale of undeliverable c. o. d. baby chick shipments. Care should be exercised to see that in each such case information is furnished as to the names and addresses of the sender and addressee, the original c. o. d. number, the amount of the sale, the commission charged, and the money order fee charged.

## INSTRUCTIONS OF SECOND ASSISTANT POSTMASTER GENERAL

### AIR POSTAL A. M. 97 TRANSPORT

Effective on or about March 7, 1949, air mail service will be inaugurated over segment No. 1 of new route A. M. 97, between Washington, D. C., Baltimore, Md., Frederick, Md., Hagerstown, Md., Martinsburg, W. Va., Cumberland, Md., Connellsville-Uniontown, Pa., and Pittsburgh, Pa.

Service on other segments will not be inaugurated at this time, however, appropriate announcement will be made when these segments are activated.

Special cachets will be provided for Washington, D. C., Air Mail Field, Washington, D. C., Baltimore, Md., Frederick, Md., Hagerstown, Md., Martinsburg, W. Va., Cumberland, Md., Connellsville, Pa., Uniontown, Pa., Pittsburgh, Pa., and Air Mail Field, Pittsburgh, Pa., and the usual treatment of philatelic mail will be authorized.

First-flight air-mail covers sent to the postmasters at the above-named offices and to the District Superintendent, District No. 6, Railway Mail Service, Washington, D. C., for Air Mail Field, Washington, D. C., and to the District Superintendent, District No. 5, Railway Mail Service, Pittsburgh, Pa., for Air Mail Field, Pittsburgh, Pa., should be accompanied by a letter authorizing the holding of the covers for the first flight and requesting the application of the cachet. Space approximately 2½ by 2½ inches to the left on the address side of all covers is required for the cachet.

No provision will be made for point-to-point covers, however, at request of collectors, covers receiving cachets will be given directional service only to a terminal or junction point designated by the Regional Superintendent, Air Postal Transport, and served by the first flight in each direction, and will there be backstamped and dispatched onward to destination.

A. gift parcels" are limited to nonperishable food, discarded wearing apparel, mailable medical supplies, and soap.

(ii) The combined total domestic retail value of all soap, butter, and other edible fats and oils included in each parcel must not exceed \$5, and the combined total domestic retail value of all streptomycin, quinine sulfate, and quinine hydrochloride included in each parcel also may not exceed \$5.

(iii) When a relief parcel is presented for mailing under these regulations the words "U. S. A. gift parcel" shall be conspicuously endorsed by the mailer on the address side of the parcel and also on the customs declaration. The use of the words "U. S. THIRD ASSISTANT POSTMASTER GENERAL**

**3-CENT MINNESOTA TERRITORY COMMEMORATIVE STAMP**

The Department will issue a 3-cent stamp through the Saint Paul, Minn., post office, on March 3, 1949, to commemorate the one-hundredth anniversary of the creation of the Territory of Minnesota.

The stamp will be 0.84 by 1.44 inches in dimensions, arranged horizontally, printed by the rotary process in green, electric-eye perforated, and issued in sheets of 50 subjects. The printing of 100,000,000 Minnesota Territory stamps has been authorized.

The central design of the stamp depicts a pioneer moving westward with a Red River ox cart. The bottom border is formed by a dark panel, in which is the working "3c United States Postage 3c" in white Gothic. In the upper left portion of the stamp, arranged in four lines of dark Gothic, is "Minnesota Territorial Centennial 1849-1949." In the same style in the upper right corner appears the lettering "Red River Ox Cart."

Stamp collectors desiring first-day cancellations of this stamp may send a limited number of addressed envelopes, not in excess of 10, to the Postmaster, Saint Paul, Minn., with postal note or money order remittance to cover the cost of the stamps to be affixed. **Postage stamps and personal checks will not be accepted in payment.** Envelopes submitted should be of ordinary letter size and each must be properly addressed. An enclosure of medium weight should be placed in each envelope and the flap either sealed or turned in. **An outside envelope must not be sent for return of first-day covers.** The envelope to the Postmaster, Saint Paul, Minn., should be endorsed "First Day Covers." Collectors should refrain from requesting hand cancellations since covers will be machine canceled so far as practicable. Orders for first-day covers must not include requests for uncanceled stamps.

For the benefit of collectors desiring stamps of selected quality for philatelic use, the 3-cent Minnesota Territory commemorative stamp will be available at the Philatelic Agency, Post Office Department, Washington 25, D. C., on and after March 4, 1949. To insure prompt shipment, mail orders to the Agency should include no other stamp issues. **The Philatelic Agency does not service first-day covers.**

Postmasters at direct and central-accounting post offices will receive an initial supply of the Minnesota Territory commemorative stamps on orders prepared in the Department. Therefore, postmasters at these offices will not submit requisitions for the same. Direct and central-accounting postmasters are furnished commemorative stamps as fast as they can be manufactured. They are, therefore, requested to refrain from reporting the nonreceipt of shipments until a reasonable time has elapsed after the first day of issue.

Postmasters at district-accounting post offices may obtain needed quantities of the Minnesota Territory commemorative stamps by requisition on the central-accounting postmaster.

**Postmasters will please post a copy of this notice on the bulletin board,** give information to the press, and notify all local stamp clubs regarding the issuance of the 3-cent Minnesota Territory commemorative stamp.

**Postmasters are cautioned not to place the stamp herein announced on sale before March 4, 1949.**

**CANADIAN INLAND CARD MONEY ORDERS TO BE PAID ONLY TO WELL KNOWN  
AND RESPONSIBLE PERSONS**

Although the new Canadian card form of money order was adopted for domestic purposes only, postmasters in this country have been authorized to effect payment in isolated cases when such an order is erroneously drawn on a post office in the United States.

The Canadian Postal Administration now reports that card forms Nos. 13,543,690, to 13,543,724, have been stolen from the post office at Toronto, Sta. 78, Ontario, and it asks that postmasters be instructed not to pay any card forms of Canadian money orders unless the payee is well known to them and is a responsible person.

Postmasters will, therefore, take note of the foregoing warning notice, and when an order issued in Canada on a domestic card money order form is presented by an unknown person, payment should be declined and the patron requested to return it to the remitter to be replaced by a proper money order that should be forwarded to him in its stead.
