## INSTRUCTIONS OF CHIEF CLERK AND DIRECTOR OF PERSONNEL

### POST OFFICE MANUAL

The 1948 edition of the Manual of Instructions for Postal Personnel is superseded by the 1952 edition bearing the new title "Post Office Manual." Distribution of the new edition is nearly completed. The number of copies printed does not permit the furnishing of a copy to all postal employees. Distribution has been made with the expectation that a copy should be in the possession of or readily available to all classified employees, including substitute employees and that the publication should be available to temporary substitute employees. In the event the quantity received at any post office is not deemed adequate for this purpose, this Office should be advised as to the number of additional copies needed. When advising of the need for additional copies, postmasters should state the number of copies of the 1952 edition received as well as the number of classified and the number of temporary employees assigned at their offices.

## INSTRUCTIONS OF ASSISTANT POSTMASTER GENERAL BUREAU OF POST OFFICE OPERATIONS

### COST OF PUBLIC LAW 204 AT SECOND- AND THIRD-CLASS POST OFFICES

This Bureau is receiving many requests for additional allowances from postmasters at second- and third-class offices to cover the cost of Public Law 204.

The attention of postmasters at offices of these classes is invited to the notice in the POSTAL BULLETIN of February 12, 1952, to the effect that it would not be necessary to request additional allowances for the purpose in question but that requests for additional allowances should be confined to the additional amount necessary to cover increase in hours of employment. Requests for additional allowances incident to Public Law 204 only will be filed without action.

## INSTRUCTIONS OF ASSISTANT POSTMASTER GENERAL BUREAU OF TRANSPORTATION

### AIR PARCEL POST TO GUADELOUPE AND MARTINIQUE

Effective July 1, 1952, air parcel-post service will be inaugurated to Guadeloupe and Martinique, subject to the general conditions stated in chapter III, article 2, paragraph II, on page 45 of the 1951 Postal Guide, Part II.

The postage rates applicable to air parcels for Guadeloupe will be \$0.65 for the first 4 ounces or fraction and \$0.20 for each additional 4 ounces or fraction, and that for Martinique will be \$0.65 for the first 4 ounces or fraction and \$0.25 for each additional 4 ounces or fraction.

## INSTRUCTIONS OF ASSISTANT POSTMASTER GENERAL BUREAU OF FINANCE

### INCREASED POSTAGE FOR BULK THIRD-CLASS MAILINGS

Postmasters are reminded that pursuant to the act of October 30, 1951 (Public Law 233), the minimum charge per piece for third-class mailings in bulk quantities under the provisions of section 34.66, Postal Laws and Regulations, will be increased to 1½ cents effective July 1, 1952. The per pound rates for such mailings will not be changed.

Each mailing under the provisions of section 34.66, Postal Laws and Regulations, must consist of at least 200 pieces or 20 pounds, all articles in the mailing identical as to size, weight, and number of enclosures, and properly separated by cities and States. Mailings which weigh less than 20 pounds and also consist of less than 200 pieces are subject to the regular third-class rates according to character of contents.

The following instructions relative to this change in the minimum charge per piece are in addition to those issued in the POSTAL BULLETINS of November 8, 1951, December 6, 1951, and April 3, 1952.

#### Computing Postage on Mailings Under Section 34.66, P. L. and R.

##### Pound or piece rate

In computing postage it is necessary to ascertain whether the pound or piece rate applies. For circulars, miscellaneous printed matter, merchandise, etc., if 14 pieces weigh 1½ pounds or less (each piece not exceeding 1.714 ounces) the per-piece rate of 1½ cents applies. Otherwise the 14-cents-a-pound rate shall be used. For books and catalogs having 24 pages or more (at least 22 of which must be printed), seeds, cuttings, plants, etc., if 10 pieces weigh 1½ pounds or less (each piece not exceeding 2.4 ounces) the per-piece rate of 1½ cents applies. Otherwise the 10-cents-a-pound rate is applicable. In no instance shall the postage on such mailings be less than 1½ cents for each piece.

##### Postage paid by precanceled stamps or meter impressions

When third-class matter is mailed at bulk rates and postage is paid by means of precanceled stamps or meter impressions the postage value affixed to each piece must be sufficient to prepay fully the amount chargeable thereon. Therefore, when postage on each piece computed at the bulk rate by the pound is not exactly equivalent to the denomination of a postage stamp or meter unit or combination thereof, it is necessary to affix to each piece a precanceled stamp or stamps or meter impression or impressions of the next higher denomination. This may amount to slightly more than postage at pound rates computed on the bulk weight of the entire mailing. The following tables are provided for convenience in computing postage in such cases:

NOTE.—Table A shows the rate per piece when the exact weight of the piece is known, or can be ascertained from scales having graduations of less than one-half ounce. Few post offices are equipped with such scales. Therefore, a simpler method to determine the amount of postage chargeable per piece is to weigh 14 pieces (or 10 pieces depending on the character of matter and rate involved) and refer to table B. For example, 14 pieces of printed matter weighing 20 ounces (1¼ pounds) are found by reference to table B to be subject to the minimum rate of 1½ cents each. Ten packages of bulbs weighing 44 ounces (2¾ pounds) are shown by table B to be subject to the rate of 3 cents each. The weights by decimal fractions shown in table A are the maximum weights of individual pieces which may be accepted at the postage value listed opposite.

Computing Postage on Mailings Under Section 34.65 (e), P. L. and R.

The law provides that the minimum rate of 1 cent per piece will continue to apply to bulk mailings of third-class matter by religious, educational, scientific, philanthropic, agricultural, labor, veterans' or fraternal organizations or associations not organized for profit and none of the net income of which inures to the benefit of any private stockholder or individual. Except as stated below all conditions for mailing and computing postage on matter under section 34.65 (e), P. L. and R., are the same as those for mailings under section 34.66, P. L. and R. Postmasters who have been authorized to accept the bulk third-class mailings of such designated organizations or associations shall determine whether the matter runs 14 or more pieces to the pound, if it consists of circulars, miscellaneous printed matter or merchandise, or 10 or more pieces to the pound, if it consists of books or catalogs of 24 pages or more, seeds, cuttings, etc., before accepting

it at the minimum rate of 1 cent each. When the individual pieces exceed these weights; that is, when the number of pieces to the pound in a mailing is less than 14 or less than 10, respectively, the postage must be charged at the rate of 14 cents or 10 cents a pound or fraction thereof, according to the character of the contents. In the latter instance where postage is prepaid by precanceled stamps or by meter impressions table A or B may be used to compute postage on the individual piece.

Mailings prepared under section 34.65 (e), Postal Laws and Regulations, shall bear the inscription "Sec. 34.65 (e), P. L. & R." either printed or hand-stamped in the upper right corner of the address side. Mailers using up stocks of envelopes, wrappers, etc., need not obliterate the inscription "Sec. 34.66, P. L. & R." if it is not convenient to do so at the time the inscription "Sec. 34.65 (e), P. L. & R." is imprinted thereon.

It is also contemplated that mailings prepared under section 34.65 (e), P. L. and R., shall bear the name and address of the authorized organization in the upper left corner on the address side. Postmasters may permit authorized organizations and associations to use up stocks of envelopes and wrappers which may already have been procured and do not bear the return card, provided the mailings are otherwise acceptable. As a matter of cooperation, mailers authorized to deposit matter at the special minimum rate should place their return card on all such mailings in addition to the inscription "Sec. 34.65 (e), P. L. & R." to avoid any confusion in the handling of the mail.

Care must be exercised to see that statements of mailing on Forms 3602, 3602-A, and 3602-PC from authorized nonprofit organizations and associations are appropriately modified to show that mailings are made under section 34.65 (e), P. L. and R., whenever the special minimum 1 cent per piece rate is charged.

Conditional Acceptance at the Special Minimum 1 Cent Per Piece Rate

In some cases nonprofit organizations or associations may wish to present bulk mailings of third-class matter under the provisions of section 34.65 (e), P. L. and R., before action can be taken on their application to be exempted from paying the increased minimum rate. If an application on Form 3624 has been filed by the organization, postmasters may accept bulk third-class mailings prepaid at the minimum 1 cent rate provided, of course, the mailings run 14 or more, or 10 or more pieces to the pound, whichever is applicable, and accept a deposit of money sufficient to cover additional postage at the rate of one-half cent per piece to be held in trust by the postmaster pending final action of the Department with respect to the application of the organization or association. A receipt on Form 3544 should be furnished the mailer covering the amount held in trust. If the application is subsequently approved the postmaster will be authorized to refund the money held in trust. On those mailings accepted conditionally as nonmetered matter which are chargeable at the minimum 1-cent per piece rate the postmaster shall determine the amount of postage at the 1-cent rate and reflect the collection thereof in his accounts by issuing receipt on Form 3603, retaining the one-half cent additional postage per piece in his trust funds pending action on the application.

Annual Bulk Mailing Fees

The \$10 annual bulk mailing fee will be continued on a calendar year basis. Mailers who have already paid the annual bulk mailing fee for 1952 may mail third-class matter under section 34.65 (e) or 34.66, P. L. and R., without having to pay another fee this year. Payment of the \$10 fee will entitle a mailer to present matter under provisions of section 34.65 (e) or 34.66, P. L. and R., or both.

Minimum Postage Charge on Third-Class Matter

Attention is directed to the minimum postage charge of 3 cents required by law on third-class matter of such form or size as to prevent ready facing, tying and handling in the mails. This applies to bulk mailings of third-class matter prepared under the provisions of section 34.65 (e) or 34.66, P. L. and R. In any instance where the bulk rate of postage per piece exceeds 3 cents, the minimum charge will, of course, not be applicable. Large circulars, folders, etc., of third-class matter when folded flat to a size of 9 by 12 inches or less will be acceptable at the bulk third-class rate. For small articles if they have flat surfaces and measure not less than 2¾ by 4 inches the bulk third-class rate will be chargeable. The 3-cent minimum charge will apply to all round, cylindrical, or other irregularly shaped pieces or packages, as well as those forming a hump or which are otherwise so uneven as to prevent stacking or tying in packages including articles in bags or which are addressed by means of tags.

In this connection attention is called to the instructions appearing on page 401, chapter 17, paragraph 12 of the Manual of Instructions for Postal Personnel, and the provisions of section 71.23, Postal Laws and Regulations.

**MOUNT RUSHMORE NATIONAL MEMORIAL COMMEMORATIVE POSTAGE STAMP**

The Department will issue a 3-cent Mount Rushmore National Memorial commemorative postage stamp through the Keystone, S. Dak., post office on August 11, 1952.

The stamp will be 0.84 by 1.44 inches in dimensions, arranged vertically with a single outline frame, printed by the rotary process, electric-eye perforated, and issued in sheets of 50. The color of the stamp will be green. The printing of 110,000,000 Mount Rushmore National Memorial commemorative stamps has been authorized.

The over-all design of the stamp is a scene of Mount Rushmore featuring the sculptured heads of George Washington, Thomas Jefferson, Theodore Roosevelt, and Abraham Lincoln. The figures of a woman and child viewing the scene are shown in the lower right-hand corner of the stamp. The wording "U. S. Postage 3¢" appears at the top of the stamp and on a sign board located in the lower right section of the stamp is the wording, "Mount Rushmore National Memorial 1927-1952", arranged in five lines. The wording "Black Hills South Dakota" is shown in the lower left corner of the stamp. All lettering is in modified gothic.

Stamp collectors and dealers desiring first day cancellations of this stamp may send a reasonable number of addressed envelopes to the Postmaster, Rapid City, S. Dak., where the preliminary work will be done, after which the covers will be forwarded to Keystone, for cancellation, etc. All money order remittances to cover the cost of the stamps to be affixed should be made payable to the Postmaster, Rapid City, S. Dak. **Postage stamps and personal checks will not be accepted in payment.**

Envelopes submitted should be of ordinary letter size and each must be properly addressed. An enclosure of medium weight should be placed in each envelope, and the flap either sealed or turned in. An outside envelope must not be sent for return of first-day covers. The envelope to the Postmaster, Rapid City, S. Dak., should be endorsed "First Day Covers". Collectors should refrain from requesting hand cancellations, since covers will be machine canceled so far as practicable. Orders for first day covers must not include requests for uncanceled stamps.

For the benefit of collectors desiring stamps of selected quality for philatelic use, the 3-cent Mount Rushmore National Memorial commemorative stamp will be available at the Philatelic Agency, Post Office Department, Washington 25, D. C., on and after August 12, 1952. To insure prompt shipment, mail orders to the agency should include no other stamp issues. **The Philatelic Agency does not service first-day covers.**

Postmasters at direct- and central-accounting post offices will receive an initial supply of the Mount Rushmore National Memorial commemorative stamps on orders prepared in the Department. Therefore, postmasters at these offices will not submit requisitions for the same. Direct- and central-accounting postmasters are furnished commemorative stamps as fast as they can be manufactured. They are, therefore, requested to refrain from reporting the nonreceipt of shipments until a reasonable time has elapsed after the first day of issue.

Postmasters at district accounting post offices may obtain needed quantities of the 3-cent Mount Rushmore National Memorial commemorative stamps by requisition on the central-accounting postmaster.

**Postmasters will please post a copy of this notice on the bulletin board, give information to the press, and notify all local stamp clubs regarding**

the issuance of the 3-cent Mount Rushmore National Memorial commemorative stamp.

**Postmasters are cautioned not to place the stamp herein announced on sale before August 12, 1952.**
