1-Cent Washington Postage Stamp

The Department will issue a 1-cent George Washington postage stamp, the third in the new ordinary series, through the Chicago, Ill., post office, on August 26, 1954, on the occasion of the annual convention of the Society of Philatelic Americans.



The stamp will be 0.75 by 0.87 of an inch in dimension, arranged vertically, and bordered with a simple picture frame effect. It will be printed by the rotary process, electric-eye perforated, and issued in sheets of 100. The color of the stamp will be green.

The stamp has for its central subject a likeness of George Washington reproduced from a portrait generally thought to be the original of the Vaughan or "right-side of the face" type, by Gilbert Stuart, now in the Mellon Collection, National Gallery of Art, Washington, D. C. The name Washington appears on the right and below the center of the portrait and in the lower left corner of the stamp, arranged in two lines, is the denomination 1¢ and the wording U. S. Postage. All lettering will be in whiteface gothic.

Stamp collectors and dealers desiring first-day cancellations of the stamp may send a reasonable number of addressed envelopes to the Postmaster, Chicago, Ill., with money-order remittance to cover the cost of the stamps to be affixed. Postage stamps and personal checks will not be accepted in Payment.

Air Service for First-Class Mail

Reference is made to the program recently inaugurated by the Department whereby ordinary first-class mail is transported by air between various sections of the country, under special arrangements with the airlines.

This service must be confined strictly to first-class mail, and under no circumstances should pieces of third-class or circular matter be included in packages of first-class mail to which this service is accorded.

Recent examinations of these mails at transit points show that various post offices are including pieces of other than first-class mail in packages made up for cities and states. Postmasters should take prompt action to insure that only first-class matter is included in such packages.

Paul C. Ledrick has been designated as Acting Assistant Postmaster General in charge of the Bureau of Transportation, effective August 1, 1954.

Lobby Display Authorized in the State of Virginia

Two posters issued by the Alcohol and Tobacco Tax Division, Internal Revenue Service, concerning a special drive now being made to detect and apprehend illicit distillers in the State of Virginia, will be distributed in the near future.

Postmasters in the State of Virginia are authorized to display these posters in a prominent location for a reasonable length of time, or until the posters no longer present a neat appearance.

The foregoing instructions do not apply to post office lobbies not operated by the Post Office Department.

New Postal Savings Procedure, Sept. 1, 1954

A stock of the new postal savings certificates on punch-card form, Series of 1954, will be furnished each depository office by its regional distributing post office before Septem-ber 1, 1954, without requisition. These certificates will be in the following denominations: \$1, \$5, \$10, \$20, \$50, \$100, \$200, \$500, \$1,000, and \$2,500. Each denomination will be bound in books of 25 certificates. Not all offices will be furnished with an initial supply of the \$1,000 or \$2,500 denomination certificates. Postmasters not receiving these higher denomination certificates in the initial shipment may requisition them from their regional distributing postmaster if there is a sufficient demand to justify their use. Do not charge this new stock in your August report on Form PS 704, but show it on your records as received September 1, 1954.

Effective September 1, 1954, postmasters will issue to depositors the new punch-card certificates Series of 1954. Under no circumstances shall the old-style paper certificates be issued after the close of business August 31, 1954.

Interest at the rate prescribed by law (2 percent per annum in all States except Mississippi where the rate is $1\frac{1}{2}$ percent per annum) shall be compounded annually on whole dollar amounts on postal savings deposits represented by individual certificates issued on or after September 1, 1954. Between annual periods or for periods of less than 1 year, simple interest as heretofore shall be allowed quarterly on such deposits. Interest, whether compound or simple, shall be computed from the first day of the month following the date of issue of certificates for all certificates issued on and after September 1.

Deposits made prior to September 1, 1954, shall continue to earn simple interest on a quarterly basis as heretofore until the certificates repre-

Envelopes submitted should be of ordinary letter size and each must be properly addressed. An enclosure of medium weight should be placed in each envelope and the flap either sealed or turned in. An outside envelope must not be sent for return of first-day covers. The envelope to the Postmaster, Chicago, Ill., should be endorsed First-Day Covers. Collectors should refrain from requesting hand cancellations since covers will be machine canceled so far as practicable. Orders for first-day covers must not include requests for uncanceled stamps.

To receive the official first-day postmark, covers must bear postage at the first-class rate, or not less than 3 cents.

For the benefit of collectors desiring stamps of selected quality for philatelic use, the 1-cent Washington ordinary stamp will be available at the Philatelic Agency, Post Office Department, Washington 25, D. C., on and after August 27, 1954. To insure prompt shipment, mail orders to the Agency should include no other stamp issues. The Philatelic Agency does not service first-day covers.

Postmasters at direct and central post offices may obtain limited quantities of the new 1-cent Washington ordinary stamp by requisition. To insure the receipt of the new stamp, a separate requisition should be submitted for the initial order, and subsequent requisitions should be endorsed New Issue when the new stamp is desired. Postmasters should submit their requisitions upon receipt of this Bulletin notice.

Postmasters at fixed credit offices may obtain limited quantities of the new 1-cent ordinary stamp by requisition on their central office.

Postmasters will please post a copy of this notice on the bulletin board, give information to the press, and notify all local stamp clubs regarding the issuance of the 1-cent George Washington ordinary postage stamp.

Postmasters are cautioned not to place the stamp herein announced on sale before August 27, 1954.

Amendments to the Code of Federal Regulations, Title 39:

Classification and Rates of Postage

In § 34.95 Parcels addressed to certain A. P. O.'s amend paragraph (b) by adding new subparagraph (6) to read as follows:

(6) Circular matter of the third class as defined in §34.67 of this chapter is not mailable to overseas A. P. O.'s. This restriction does not apply to other third-class matter such as house organs, news or church bulletins, books and catalogs.

senting such deposits are surrendered either for cash or in exchange for new certificates.

The new certificates shall bear the name of the issuing office and the date of issued (in red, if practicable) in the space provided on the upper right portion of the certificate. A stamp for this purpose is being furnished each depositary office and must be kept in good condition to show a legible impression. It will not be necessary to state the date when interest begins on the new certificates because it will always be the first day of the month following the date of the issue of the certificate. The account number and the name of the depositor shall be stated on the left portion of the certificate in the spaces provided. The number of the depositor's account, the date of issue, and the initials of the issuing clerk will be stated opposite the last two digits of the certificate serial number on the top cover of its book. When a book is exhausted, the cover card should be appropriately filed for future reference.

Various instructions pamphlets, interest tables, accounting forms, and Forms PS 600 and PS 600-A are being revised and will be furnished postmasters without requisition. Instructions concerning the revised accounting forms and the posting of Forms PS 600 and PS 600-A will be issued at a later date. Instructions concerning the disposition of the unused postal savings certificates which will become obsolete September 1 will be issued on or about that date.

Placards announcing the new method of computing interest and the new card postal savings certificates will be furnished each depositary office and, immediately upon receipt, should be displayed conspicuously in the lobby of the office so that depositors will be informed of the changes.

The success of the new card certificates is dependent on their being kept in good condition, and nothing should be attached to them either by adhesion, stapling, or pinning. Depositors should be requested not to bend, fold, or mutilate them in any way.
