All Postal Installations

7-Cent Alaska Statehood Commemorative Airmail Postage Stamp

The Department will issue a 7-cent Alaska Statehood commemorative airmail stamp through the Juneau, Alaska, post office on the date of the President's proclamation of Alaska's admission to the Union.



The stamp will be 0.84 by 1.44 inches in dimension, arranged horizontally, electric-eye perforated and issued in sheets of 50. The color of the stamp will be blue. An initial printing of 90,000,000 has been authorized.

The stamp features the "Big Dipper" and North Star as portrayed on the Alaskan flag, superimposed on a map of Alaska. In the background are wooded hills and snow-topped mountains, indicative of the terrain and the vastness of the area and its wealth. In the left portion of the stamp, in dark gothic lettering outlined in white, is "U. S. Air Mail," in two lines, and "7¢," while across the bottom in lighter modified gothic lettering against a plain background is "Alaska Statehood 1959."

Latest information indicates Alaska will be admitted to statehood early in January.

To facilitate the availability of the new 7-cent airmail Alaska Statehood stamps to the public Postmasters at first-class post offices requiring this issue in lots of 25,000, or multiples thereof, will requisition these stamps immediately from the Office of Industrial Services, Bureau of Engraving and Printing, Washington 25, D. C. Offices requiring less than 25,000 stamps shall submit requisitions immediately to their Regional Distributing Office.

An advance distribution of these stamps has been made to some offices. The wrappers of this advance distribution do not bear the usual warning

Argentina Prohibits Currency and Values Payable to Bearer

The postal administration of Argentina has advised that banknotes, coins and values payable to bearer may not be sent to that country by Postal Union mail or parcel post. The prohibition does not apply to checks or other instruments payable to a specific person or firm.

Endorsement of Airmail Registered Articles

Registered articles prepaid for airmail transmission to other countries are being received at our dispatching international exchange post offices without airmail endorsements.

Postmasters must see that employees accepting registered mail place a "Par Avion" label or endorsement, where the mailer has failed to do so, on any article which is prepaid for airmail conveyance to the country of destination. Sec. 231.4, Postal Manual.—Bureau of Transportation, 12-31-58.

Air Transportation, American Airlines, Inc.

Effective on or about January 25, 1959, American Airlines will inaugurate the first transcontinental jet airmail service over a domestic airline route. The service will operate between New York and Los Angeles.

Official cachets will be furnished for New York, N. Y.; Airport Mail Facility Idlewild, N. Y.; Los Angeles, Calif., and Airport Mail Facility Los Angeles, Calif. The usual philatelic treatment, outlined in 145.3 Postal Manual, is authorized.—Bureau of Transportation, 12-31-58.

Fraud Orders Against Various Concerns in British Guiana

The attention of all postmasters is directed to Fraud Order No. 33960 issued on February 6, 1947, against the Demerara Stamp Co., and Noor Mohammed, at Demerara, British Guiana, and to Fraud Order No. 55104 issued on April 6, 1953, against John Mohammed; Noor Mohammed & Co.; M. Ida & Co.; British Colonial Agency; International Co.; Robert Singh & Co.; Rose Khan & Co.; B. A. C. Importing Co. at Georgetown, British Guiana, and Hakim Mohammed & Co., at Albouystown, British Guiana. The Department has received information indicating that despite the provisions of these fraud orders mail is being dispatched from the United States to the concerns and parties named therein. All postal personnel handling mail for dispatch to British Guiana should be requested to make every effort to fully enforce these orders .- Office of the General Counsel, 12-31-58.

notice relative to first-day sales. However, under no circumstances shall the stamps be sold prior to the day following the first-day sale in Juneau, Alaska.

Postmasters should watch closely for the announcement of the President's proclamation of Alaska statehood in their local newspapers and on TV and radio stations. On the day of Alaska's admission to the Union the Alaska Statehood stamps will be placed on first-day sale only in Juneau, Alaska. The following day, or as soon as these stamps are available, they should be placed on sale in all post offices.

Postmasters are reminded of the notice by the Postmaster General in the September 11, 1958, issue of the Postal Bulletin requiring Postmasters to submit requisitions for each new stamp issue as announced in the Postal Bulletin so that ample quantities will be available at all post offices as soon as possible after official first-day sale.

Collectors desiring first-day cancellations of the 7-cent Alaska Statehood commemorative airmail stamp may send addressed envelopes, together with remittance to cover the cost of the stamps to be affixed, to the Postmaster at Juneau, Alaska. Envelopes submitted should be of ordinary letter size and each must be properly addressed. An envelope must not be sent for return of firstday covers. Collectors should refrain from requesting hand cancellations since covers will be machine canceled so far as practicable. Orders for first-day covers must not include requests for uncanceled stamps. The outside envelope to the post-master should be endorsed "First Day Covers Alaska Statehood Stamp."

For the benefit of collectors desiring stamps of selected quality for philatelic use, the 7-cent Alaska Statehood commemorative airmail stamp will be available at the Philatelic Sales Agency, Post Office Department, Washington 25, D. C.

To insure prompt shipment, mail orders to the Agency should include no other stamp issues. The Philatelic Sales Agency does not service first-day covers.

All Post Offices in Cities Over 25,000 Population

Form 123, Office Space Report

Under instructions currently in effect, postmasters in cities of over 25,000 population submit periodic reports to the General Services Administration on Form 123 covering certain categories of office space used for post office purposes in Federal buildings which are not exclusively postal.

Pursuant to advice from General Services Administration, postmasters are advised that the report scheduled to be made as of December 31, 1958 will not be required.—Bureau of Facilities, 12-31-58.

First-Class Post Offices

Shipping Containers for Postage Stamps

Effective on or about January 10, 1959, postage stamps will no longer be dispatched from Washington in rotary lock pouches. Larger and sturdier corrugated cardboard containers will be used and each container will be billed in transit as a separate registered piece.

The larger cartons, weighing from approximately 30 to 50 pounds, are to be handled as outside pieces. When hand-to-hand receipts are not exchanged for these cartons, they are to be billed in accordance with instructions in section 361.123b (3) of the Postal Manual.

A smaller carton, weighing under 20 pounds, also is to be used. There is no objection to pouching these cartons where space is available in an iron-lock pouch, but they may also be handled as outside pieces.

Beginning January 5, 1959, postmasters requiring bulk quantities of postage stamps shall requisition in accordance with the following table: SHEET STAMPS:

COILS OF STAMPS:

Postmasters should submit orders for full carton lots whenever possible.
