# 4-Cent St. Lawrence Seaway Commemorative Postage Stamp

The Department will issue a 4-cent St. Lawrence Seaway Opening commemorative stamp through the Massena, N.Y., post office on June 26, 1959. A stamp identical in design, except for the necessary differences in the caption and denomination, is being released simultaneously, at Ottawa, Canada. The Canadian stamp will be in the 5-cent denomination.

POSTMASTERS SHALL NOT PLACE THIS STAMP ON SALE BEFORE JUNE 27, 1959



The stamp will be 0.84 by 1.44 inches in dimension, arranged horizontally, printed on the Giori press in red and blue on white paper, and issued in sheets of 50. An initial printing of 120 million of these stamps has been authorized.

Reproduced on the stamp are the emblems of both nations, the maple leaf for Canada, and the eagle for the United States, enclosed in interlocking links superimposed over a background of the Great Lakes. Across the top of the stamp is the wording "St. Lawrence Scaway" and across the bottom "United States." To the left of the design is the lettering "Postage," arranged vertically, and the denomination "4¢" appears in the lower right corner of the stamp.

Collectors desiring first-day cancellations of the 4-cent St. Lawrence Seaway commemorative stamp may send addressed envelopes, together with remittance to cover the cost of the stamps to be affixed, to the Postmaster, Massena, N.Y. # Minimum Size for Domestic Mail

The minimum size restriction of 23/4 by 4 inches, effective July 1, 1959, for envelopes and cards set forth in sections 131.32, 134.32, and 137.252, Postal Manual, is hereby suspended indefinitely.

In addition, section 134.22c (2), under "Note" in the Postal Manual, will be changed to read:

The address side is less than 23/4 inches in width or 4 inches in length.—Bureau of Operations, 5-7-59.

ness should be placed in each envelope and the flap either turned in or sealed. Envelopes submitted should be of ordinary letter size and each must be properly addressed. An envelope must not be sent for return of first-day covers. The outside envelope to the postmaster should be endorsed "First Day Covers 4¢ St. Lawrence Seaway Stamp." Orders for covers must not include requests for uncanceled stamps.

For the benefit of collectors desiring stamps of selected quality for philatelic use, the 4-cent St. Lawrence Seaway commemorative stamp will be available at the Philatelic Sales Agency, Post Office Department, Washington 25, D.C., on and after June 27, 1959. To insure prompt shipment, mail orders to the Agency should include no other stamp issues. The Philatelic Sales Agency does not service first-day covers.

Postmasters are directed to submit requisitions for each new stamp issue as announced in the Postal Bulletin so that ample quantities will be available at all post offices on the following day after official first-day sale.

# Migratory Bird Hunting Stamps

Postmasters at offices of the first and second classes as well as thirdand fourth-class offices having a demand for Migratory-Bird Hunting Stamps shall submit requisition Form 017 Stamp Requisition to their regional distributing office on or about June 1 for stamps of the 1959-1960 series. Estimate requirements carefully to eliminate additional requisitions. The 1959-1960 Series Migratory-Bird Hunting Stamp is being printed in multicolor on the Giori press and issued in sheets of 30. Therefore, postmasters should order this stamp in multiples of 30 (except that offices requiring a lesser quantity may order 15 stamps). Last year Congress passed legislation increasing the selling value of Migratory-Bird Hunting Stamps from \$2 to \$3.

The subject featured on the 1959–60 Federal Migratory Bird Stamp is a Labrador retriever carrying a mallard drake.

Sections 172.22, 422.21, and 422.52c of the Postal Manual are being amended.—Bureau of Facilities, 5-7-59.

Postmasters at first- and secondclass post offices requiring this issue in a minimum lot of 5,000, or the multiples outlined in Part 422.322 of the Postal Manual, will submit Form 3356, punchcard requisition (using Item No. 415) immediately to the Tabulating Machine Unit, Office of the Controller, Bureau of Engraving and Printing, Washington 25, D.C. Offices requiring less than 5,000 stamps shall submit a separate requisition immediately on Form 017 to their regional distributing office. Requisitions including other stamps will be delayed.

Postmasters shall post a copy of this notice on the bulletin board and give information to the press regarding the issuance of the 4-cent St. Lawrence Seaway commemorative postage stamp.—Office of the Special Assistant to the Postmaster General, 5-7-59.

# **Deodorizing Restrooms**

Reports of malodorous conditions in washrooms and toilet rooms at various offices throughout the service are cause for much concern in the Department. Closer attention is necessary to follow instructions covering procurement and use of materials to keep these areas clean and free from unpleasant odors.

Postmasters are directed to take necessary action to eliminate these conditions and prevent their recurrence through the use of Item C-1461, Deodorant. A supply will be forwarded to each first- and second-class offices without requisition. Future requirements of this item may be obtained from your area supply center on regularly scheduled requisitions.

Item C-1461 shall be used in accordance with instructions provided with each package. In addition to these instructions, the use of a sponge is recommended to clean toilet seats and exterior surfaces of commodes and urinals.

Experience has demonstrated that once a malodorous condition has been brought under control, the following procedure is usually successful in preventing its recurrence:

Each day for a period of 6 days—place 2 ounces of deodorant powder in each toilet bowl or urinal at a time that will permit it to remain in the fixture without flushing, overnight or for a period of 6 to 8 hours. Thereafter, place 2 ounces of deodorant powder in each fixture every 2 weeks, in the same manner.

In the event odor conditions recur, daily use as directed by the instructions on the label should be resumed.—Bureau of Facilities, 5-7-59.

# Advertisements of Merchants Lottery Schemes

Many postmasters are treating as mailable under the lottery law (Postal Manual 124.41) announcements of prize drawings conducted by various merchants who distribute chance tickets with purchases. Postmasters should note that these schemes are lotteries even though tickets may also be obtained without making a purchase. If there is doubt in a particular case as to whether the scheme is a lottery, the question should be submitted to the General Counsel for instructions (Postal Manual 331.6).—Office of the General Counsel, 4-30-59.

# **Delayed Handling of** Misthrown and Marked-up Mail

The Department continues to receive reports of carriers failing to promptly handle misthrown and readdressed mail to permit redistribution and delivery without delay. It is also reported that many carriers are leaving on their delivery trips without making a final withdrawal of mail from the redistribution case, and in many cases misthrows and pieces to be forwarded are not being given attention by distribution employees.

Postmasters will review present procedures at their offices to insure that the provisions of section 352.33, Postal Manual are complied with in all cases. As an aid in expediting the handling of this type of mail, supervisors should follow these basic procedures:

- 1. Instruct carriers to pass misthrows to adjacent carrier routes as they case letter mail and return other misthrown and readdressed mail promptly to redistribution cases before casing flat mail or performing other office work.
- 2. Instruct distribution clerks assigned to redistribution cases to circulate among the carriers and call for misthrown and readdressed mail when time permits.
- 3. Insure that carriers make a final withdrawal of mail from the redistribution case prior to leaving the office on their delivery trips.—Bureau of Operations, 5-7-59.

# Parcel Post Delivery

An increasing number of claims against the Government for injury to persons and damage to property has resulted from parcel post being left on porches, steps, and in poorly lit hallways.

In the absence of the patron, packages are not to be left where they are exposed to the weather or to depredations, or where there is the possibility of injury to persons falling over them.

If adequate protection is not afforded an ordinary parcel too large for the receptacle or mail slot, by leaving behind screen or storm doors or near inside doorways in apartment buildings, or there is any risk of personal injury to the patrons or others, leave Form 1513 indicating the article will be held at the office awaiting call, and mark the package to show the date the notice was left. (See 352.55 for follow-up action.)

Where patrons are regularly away during normal delivery hours it is expected that a written order to leave parcels in their absence will be on file at the delivery unit.

Supervisors will see that the instructions in 154.82 and 352.55 are followed.—Bureau of Operations, *5-7-59*.
