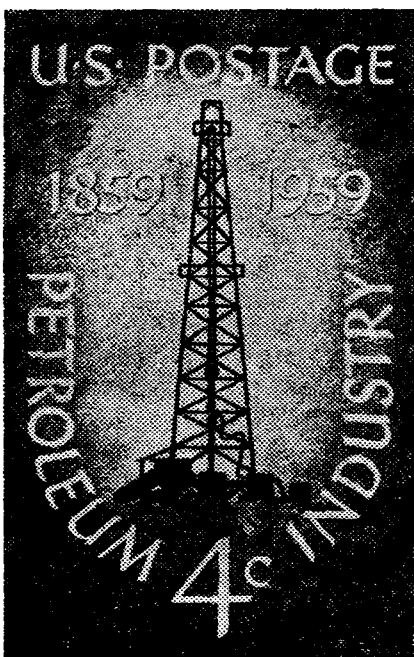

All Postal Installations

4-Cent Petroleum Industry Centennial Commemorative Postage Stamp

The Department will issue a 4-cent commemorative postage stamp through the Titusville, Pa., post office, on August 27, 1959, to mark the hundredth anniversary of the completion of the first oil well by Colonel Edwin L. Drake.

POSTMASTERS SHALL NOT PLACE THIS STAMP ON SALE BEFORE AUGUST 28, 1959



An oil derrick, against a light background, will highlight the design of the 4-cent Petroleum Industry commemorative stamp. This stamp will be 0.84 by 1.44 inches in dimension, arranged vertically, printed by the rotary process, electric-eye perforated and issued in sheets of 50. The color of the stamp will be brown. An initial printing of 120,000,000 has been authorized.

Collectors may obtain first-day cancellations by submitting requests to the Postmaster at Titusville, Pa., in accordance with the instructions outlined in section 145.3 of the Postal Manual.

First- and Second-Class Post Offices

Sweeping Tool, Item C-1859

There is now available in all area supply centers a sweeping tool, Item C-1859, to be used with Item C-1853, disposable treated non-woven cloths.

These cloths and tools are to be requisitioned only by those offices which are located in areas where rental service for tools and treated cloths is not available. In addition to their use with the sweeping tool, the disposable cloths should also be used for hand dusting.

The Supply Catalog POD Publication 24 and Facilities Handbook, Series S-3; *Floors—Care and Maintenance*, will be revised accordingly.—*Bureau of Facilities, 7-23-59.*

For the benefit of collectors desiring mint stamps of selected quality for philatelic use, the 4-cent Petroleum Industry commemorative stamp will be available at the Philatelic Sales Agency, Post Office Department, Washington 25, D.C., on and after August 28, 1959.

Postmasters are directed to submit requisitions for each new stamp issue as announced in the Postal Bulletin so that ample quantities will be available at post offices on the following day after official first-day sale.

Postmasters at first- and second-class post offices requiring this issue in a minimum lot of 5,000, or the multiples outlined in Part 422.322 of the Postal Manual, will submit Form 3356, punch card requisition (using Item No. 422) **immediately** to the Tabulating Machine Unit, Office of the Controller, Bureau of Engraving and Printing, Washington 25, D.C. Offices requiring less than 5,000 stamps shall submit a **separate requisition immediately** on Form 017 to their regional distributing office. Requisitions including other stamps will be delayed.—*Office of the Special Assistant to the Postmaster General, 7-23-59.*

Inauguration of Jet Airmail Service

(1) Continental Airlines, Inc.—AM-29

On or about August 15, 1959, Continental Airlines, Inc., will inaugurate jet airmail service between Chicago, Kansas City, Denver, and Los Angeles.

Official cachets will be furnished for the post offices and for the airport mail facilities at each of these cities.

(2) Trans World Airlines, Inc.—AM-2

On or about August 21, 1959, Trans World Airlines, Inc., will inaugurate jet airmail service between Chicago and San Francisco, and also between St. Louis, Los Angeles, and San Francisco.

Official cachets will be furnished for the post offices and for the airport mail facilities at each of these cities.

The usual philatelic treatment, outlined in 145.3, Postal Manual, is authorized for all of the above service.—*Bureau of Transportation, 7-23-59.*

Star Routes***Operation of Star Routes**

Reports received in the Department indicate that postmasters and other installation heads are not complying with the provisions of 521.7, Postal Manual. The most common omissions are failures to keep records of performance of star routes on Form 5399, *Record of Performance of Star or Water Routes*, and to make special reports of irregularities as required by 521.731, Postal Manual.

Postmasters and supervisors concerned are directed to take action to see that all necessary records are kept and reports made. Field Services Officers will check to see that these instructions are followed when visiting the designated offices.

It has also been observed that star route contractors are permitted to leave post offices ahead of schedule, even at times of day when the offices are open and receiving mail from the public which may be due for dispatch on the routes. There is no objection to star routes or other highway transportation services operating ahead of schedule during hours when offices are not open, or at times when the public is not depending on closing times for deposit of mail for the routes. However, mail should not be closed or contractors permitted to depart ahead of schedule, if there is any possibility of mail being delayed by missing dispatches.—*Bureau of Transportation, 7-23-59.*

*All Post Offices***Endorsing Undeliverable
Mail for Return to Sender**

Each piece of mail returned **undeliverable as addressed** must be endorsed to show the reason for non-delivery as prescribed in § 355.11, Postal Manual.

Numerous complaints have been received regarding the return of quantities of undeliverable third-class mail to the sender in bundles with only the top piece or label endorsed to show the reason for nondelivery. This method of returning quantities of undeliverable mail has caused unnecessary rehandling of mail and has deprived the mailer of information essential to the correction of his maintained lists.

This practice must be discontinued and each returned undeliverable piece endorsed in accordance with the provisions of the above section.—*Bureau of Operations, 7-23-59.*
