All Postal Installations

4-Cent Dental Health Commemorative Stamp

The Department will issue a 4-cent Dental Health commemorative postage stamp through the New York, N.Y., post office, on September 14, 1959, during the centennial meeting of the American Dental Association.

POSTMASTERS SHALL NOT PLACE THIS STAMP ON SALE BEFORE SEPTEMBER 15, 1959



This stamp will be 0.84 by 1.44 inches in dimension, arranged horizontally, printed by the rotary process, electric-eye perforated and issued in sheets of 50. The color of the stamp will be green. An initial printing of 120,000,000 has been authorized.

Collectors may obtain first-day cancellations by submitting requests to the Postmaster, New York 1, N.Y., in accordance with the instructions outlined in section 145.3 of the Postal Manual.

For the benefit of collectors desiring mint stamps of selected quality for philatelic use, the 4-cent Dental Health commemorative stamp will be available at the Philatelic Sales Agency, Post Office Department, Washington 25, D.C., on and after September 15, 1959.

Postmasters are directed to submit requisitions for each new stamp issue as announced in the Postal Bulletin so that ample quantities will be available at post offices on the following day after official first-day sale.

Inauguration of New Airmail Service

(1) West Coast Airlines, Inc.— AM-77

On or about September 1, 1959, West Coast Airlines, Inc., will inaugurate airmail service at Salt Lake City, Logan, and Ogden, Utah, and Omak, Wash.

Official cachets will be furnished for the post offices at each of these cities and for the airport mail facility at Salt Lake City.

(2) Frontier Airlines, Inc.—AM-73

On or about September 1, 1959, Frontier Airlines, Inc., will inaugurate airmail service at Great Falls and Lewistown, Mont.

Official cachets will be furnished for the post office at each of these cities.

The usual philatelic treatment, outlined in 145.3, Postal Manual, is authorized for all of the above service.—Bureau of Transportation 8-6-59.

Postmasters at first- and secondclass post offices requiring this issue in a minimum lot of 5,000, or the multiples outlined in Part 422.322 of the Postal Manual, will submit Form 3356, punch card requisition (using Item No. 424) immediately to the Tabulating Machine Unit, Office of the Controller, Bureau of Engraving and Printing, Washington 25, D.C. Offices requiring less than 5,000 stamps shall submit a separate requisition immediately on Form 017 to their regional distributing office. Requisitions including other stamps will be delayed.

After first-day sale, requisitions for this stamp may be combined with other items in the usual manner, when ordering regular stamp stock.-Office of the Special Assistant to the Postmaster General, 7-23-59.
