

All Postal Installations

4-Cent and 8-Cent Ernst Reuter Postage Stamps

The Department will issue a 4-cent and an 8-cent Ernst Reuter stamp, the fifth in the "Champions of Liberty" series, through the Washington, D.C., post office, on September 29, 1959.

POSTMASTERS SHALL NOT PLACE THESE STAMPS ON SALE BEFORE SEPTEMBER 30, 1959





The stamps will be 0.85 by 0.98 of an inch in dimension (Famous American size), arranged vertically. The 4-cent denomination will be issued in sheets of 70 (7 across and 10 deep) while the 8-cent de-

City Delivery Offices

Prompt Distribution of Patron-Separated Mail

There are many reports that patron-separated mail is not being given the most expeditious treatment possible. This is a program of mutual advantage to the patron and the Department. Every postmaster is asked to determine that at his office the following steps are being taken:

1. In making collections from dual boxes and cooperative mailing racks, separation is being maintained in properly labeled collection sacks.

2. That the mail for local delivery is moved promptly to the incoming mail section.

3. That all patron-separated mail for local delivery reaching the outgoing mail section is segregated and moved frequently to the incoming mail section.

4. The distribution of the patronseparated mail for local delivery is begun immediately in the incoming mails section and kept current in order that any wrongly separated mail can be moved to the outgoing mail section for the first dispatches.

The patron has cooperated. We must give his mail the best possible service.—Bureau of Operations, 8-27-59.

No Insurance Service to Cuba, Dominican Republic, and Venezuela

Parcels erroneously accepted for insurance to Cuba, Dominican Republic, and Venezuela are frequently received for onward dispatch from this country.

The tabulated data in the Directory of International Mail shows that insurance service is **not** available to the three countries mentioned.

Postmasters are requested to assure that clerks accepting parcels addressed for delivery abroad are governed by the instructions in the Directory of International Mail.—Bureau of Transportation, 8-27-59.

U.S. Savings Stamps

This year the Treasury Department is again sponsoring a school savings program to promote the sale of United States savings stamps and bonds. The Post Office Department will cooperate, as in the past, with the Treasury in this worthwhile program. Postmasters will furnish savings stamps on consignment to qualified Treasury Savings Stamp Agents for sale in schools as set forth in 423.8, Postal Manual.

The Peace Patrol inaugurated last year will be continued. It is cosponsored by the Lone Ranger, popular hero of the movies, radio, and television. Anyone buying U.S. savings stamps is eligible to join the Peace Patrol and receive an official membership card.

All postmasters are requested to examine their stock of savings stamps, savings stamp albums, and Peace Patrol membership cards and promptly requisition needed replacements before the beginning of the new school year.—Bureau of Finance, 8-27-59.

nomination will be issued in sheets of 72 (8 across by 9 deep). The 4-cent denomination will be printed on the Cottrell press in a single color—bronze-green, and the 8-cent denomination will be printed on the Giori press in red, blue, and ocher. Initial printing orders of 120,000,000 4-cent and 40,000,000 8-cent Ernst Reuter stamps have been authorized.

Collectors may obtain first-day cancellations by submitting requests to the Postmaster, Washington 13, D.C., in accordance with the instructions outlined in section 145.3 of the Postal Manual.

For the benefit of collectors desiring mint stamps of selected quality for philatelic use, the 4-cent and 8-cent Ernst Reuter stamps will be available at the Philatelic Sales Agency, Post Office Department, Washington 25, D.C., on and after September 29, 1959.

Postmasters are directed to submit requisitions for each new stamp issue as announced in the Postal Bulletin so that ample quantities will be available at post offices on the following day after official first-day sale.

Postmasters at first- and secondclass post offices requiring the 4-cent issue in lots of 7,000 and the 8-cent denomination in lots of 7,200, or the multiples outlined in parts 422.322c and 422.322d of the Postal Manual, respectively, will submit separate requisitions immediately for each denomination on punch card requisition Form 3356 (using Item No. 477 for the 4-cent and Item No. 491 for the 8-cent denomination) to the Tabulating Machine Unit, Office of the Controller, Bureau of Engraving and Printing, Washington 25, D.C. Offices requiring less than these quantities shall submit a separate requisition immediately on Form 017 to their regional distributing office. Requisitions including other stamps will be delayed. After the first-day sale, requisitions for these stamps may be combined with other items in the usual manner when ordering regular stamp stock.—Office of the Special Assistant to the Postmaster General, 8-27-59.

International Mail—Perishable Biological Materials

The instructions printed in the POSTAL BULLETIN of July 30, 1959, giving the conditions for mailing perishable biological materials, including those of pathogenic nature, in the postal union mail by letter package, are not to be construed as prohibiting such matter in the parcel Perishable biological post mail. materials may be sent by parcel post to any country which does not specifically prohibit them. Such parcels do not require the violet labels prescribed for letter packages.—Bureau of Transportation, 8-27-59.

All Post Offices With Community Chest or United Fund Die Hubs

Special Cancellation Community Chest and United Fund Die Hubs

Postmasters who have special cancelling machine die hubs for Community Chest or United Fund campaigns in their possession shall ascertain from local organizations when such campaigns will be in progress and shall place these special hubs into use about 2 weeks before the opening of the formal campaign periods. Continue to use the hubs for the duration of the campaign. After that time they shall be withdrawn and retained for future use.

These special hubs were bought by the sponsors and furnished to post offices designated by them. Postmasters at offices which do not already have the hubs shall not submit requisitions or requests for them.—

Number All International Insured Parcels

Reports show that exchange offices continue to receive numerous unnumbered insured parcels addressed to other countries.

Sections 387.211b and 387.213a of the Postal Manual provide that **all** international insured parcels must be numbered.

Postmasters are requested to have this requirement strictly observed.— Bureau of Transportation, 8-27-59. All Post Offices

Stolen Canadian Money Order Forms

Blank Canadian money order forms Nos. A-73,032,038 to A-73,032,500, inclusive, have been reported stolen.

Notice of this theft must be added to the list of stolen Canadian forms at all points of payment.

If any of these forms is presented the postmaster will refuse payment and notify the postal inspector in charge of his district.—Bureau of Finance, 8-27-59.

International Mail—Letter Packages Containing Biological Materials

The postal administrations of Barbados, Falkland Islands, and Spain have agreed to accept perishable biological materials in letter packages under the conditions prescribed by the Universal Postal Convention of Ottawa.

Those countries should therefore be added to the list printed in the Postal Bulletin of July 30, 1959.

The Postal Manual will be amended.—Bureau of Transportation, 8-27-59.
