Higher Level Pay

In the monthly consultative meeting with the National Association of Postal Supervisors on October 19, 1966, the Department stated that line supervisors detailed to the following positions would receive higher level pay immediately:

- General foreman, mails, any level.
- Assistant tour superintendent, any level.
- Superintendent of mails, PFS-7 and below.
- Assistant station superintendent, any level.

All Rural Delivery Offices

Rural Route Maps

All offices with rural delivery service are required to keep on hand an up-to-date map for each rural route showing the correct line of travel of the carrier. The **only exception** to this requirement applies to a rural route where (1) **delivery characteristics are similar to those of a city motorized route and, also (2) the use of street names and house numbers for all patrons has been authorized.** A map is not necessary for this type of rural route.

Since regional offices no longer maintain rural route maps, it is all the more important that the maps on file at post offices be current and accurate. Postmasters or supervisors are directed to make an immediate review of local rural maps for completeness and accuracy. Compare the entire line of travel on the map with the official description shown on Form 4003, *Official Rural Route Description*, and continuation sheet 4003-A, where used. **In addition, for purposes of showing where each route begins and ends delivery service, indicate with a "B" the first box served, and with an "E" the last box served.** Verify the information by discussion with the rural carrier if necessary. (The travel description is not shown on Form 4003 under certain conditions outlined in sec. 353.134, Postal Manual.)

Regional representatives will give special attention to these instructions during visits to rural delivery post offices.—*Bureau of Operations, 12-8-66.*

Mail for Military Personnel

Postmasters and other postal employees are reminded to take the following action to insure the most expeditious service possible in handling mail for military personnel:

1. Wherever possible accepting employees should carefully check mailing addresses for completeness including proper five-digit APO or FPO number.
2. Provide assistance to mailer in determining proper APO or FPO number when necessary.
3. Insure that SAM parcel mail is properly identified at time of mailing.
4. Postmasters should assure that all concerned are provided with the necessary makeup and dispatch instructions and establish adequate verification of these dispatches to eliminate, insofar as is possible, missent or delayed mail. Particular care should be taken to avoid missending of properly addressed mail; for example, mail addressed to APO or FPO New York being missent to San Francisco or Seattle.—*Bureau of Operations and the Bureau of Transportation and International Services, 12-8-66.*

Monthly Labor-Management Meeting

During the November labor-management meeting with the seven employee organizations having exclusive recognition at the national level, the following items were discussed and disposed of as indicated. The disposition represents current departmental policy with regard to the subject matter and is to be observed by all field employees:

(1) Right of employees to be represented when being questioned or interviewed by local supervision concerning an alleged deficiency. The employee is informed by management officials that he is being asked only for an explanation of an alleged deficiency. Employee is then instructed to write and sign a statement regarding the information developed in this interview which, later, is used as a basis of proposed adverse action. This does not come under the policy of discipline as the employee is interviewed by supervisors other than his immediate supervisor.

Disposition: The following subcommittee report was accepted by the full committee:

If the purpose of the interview is to discuss with the employee an alleged deficiency which would be an appropriate subject for counseling only one supervisor may be present. If more than one supervisor is present, it is a violation of the national agreement.

(2) The right of management to use Standard Form 58 "Supplemental Experience and Qualifications Statement" for filling a level 4 position.

Disposition: The following subcommittee report was accepted by the full committee:

Standard Form 58 should not be used for bidding on preferred assignments. Post Office Department Form 1717 should be used for this purpose.

(3) Overweight of mail sacks. Since the maximum weight of 80 pounds now allowed in mail sacks, is one of the causes of employee injuries, it is requested that the weight be lowered to 60 pounds.

Disposition: The Department stated that the Bureau of Personnel has been looking into this matter for some time, and a study is being made to determine the best maximum weight of mail sacks considering all factors including employee safety and physical welfare.

(4) Interpretation of Postal Manual sections 721.761 and 721.765. Question: An employee who is scheduled for more than 15 days of military training is ordered to report for advance military duty. Does this then make the employee eligible for taking his military leave as provided in 721.765.

Disposition: Yes, section 721.765 of the Postal Manual applies in this case.

(5) Are health units located in postal facilities required to treat on the job illnesses of postal employees? If so, to what extent are they required to render treatment?

Disposition: Health units shall give limited treatment, and in cases of emergency, arrange for needed care. If there is no health unit, emergency care shall be given and arrangements made for further medical treatment.

(6) Establishment of basic work weeks. We have been advised that in one region, the director has sustained a postmaster decision that supervisors are senior to clerks by virtue of their level to receive first preference for days off.

Disposition: Preference for scheduled workweek for craft employees is by seniority within the craft, and among supervisors on basis of total service as a supervisor in position and level.

(7) Has the Department's policy on the use of satchel carts by letter carriers been changed?

Disposition: The following subcommittee report was accepted by the full committee:

No—the Department's policy has not been changed.

(8) The National Federation of Post Office Motor Vehicle Employees, AFL-CIO, requests that the estimated repair time in the vehicle maintenance section of the motor vehicle service be eliminated.

Alien Address Report

The Immigration and Nationality Act of 1952 requires each alien who is in the United States on January 1, 1967, to report his current address to the Commissioner of Immigration and Naturalization within the period January 1 through January 31, 1967.

All post offices throughout the United States including Guam, the Commonwealth of Puerto Rico, and the Virgin Islands will participate in this program to the extent of distributing the address report card, Form I-53, to the alien, collecting the completed cards and forwarding them to designated offices of the Immigration and Naturalization Service.

1. **General.** Section 265 of the Immigration and Nationality Act of 1952 provides that any alien required to be registered under that act or the Alien Registration Act of 1940, who is in the United States on January 1, 1967, and each year thereafter, shall within 30 days following such date, notify the Commissioner of Immigration and Naturalization in writing of his current address. In the case of an alien for whom a parent or legal guardian is required to apply for registration, the notice required shall be given by such parent or legal guardian.

2. **Who must report.** Every non-citizen except those not required to be registered, who is in the United States on January 1, 1967, must submit an address report. Aliens required to report include:

a. Aliens residing permanently in the United States.

b. Aliens admitted for temporary periods, as visitors, transients, students, etc.

c. Aliens who, through violation of immigration laws, are in the United States illegally.

Note: Postmasters will not interpret the act, but in case of doubt as to the requirements may advise the alien to file a report.

3. **Penalty for noncompliance.** The Immigration and Nationality Act provides various penalties for failure to give the written notice of address as required including, when failure is willful or inexcusable, the possibility of deportation.

PROCEDURE

4. **Form to be used.** The address reporting card (Form I-53) to be used in January 1967, is a manila punch card form with instructions for completing the card on the left side of the form. The card form is similar to the one used for 1966. Any stocks of the 1966 form, which can be easily distinguished because of the year at the top of the card, should be destroyed. The 1967 address report card must not be mutilated, bent, spindled, or torn. The alien will complete the form. All items, except the signature, are to be typed or printed in ink or indelible pencil. Form AR-11 (Change of Address Card), which is used for the alien to report changes of address, must not be used to comply with this requirement of section 265 of the act.

5. **Distribution of forms.** The Immigration and Naturalization Service will mail each postmaster a supply of cards based on the alien population of the area served by the post office. Postmasters in large cities will be furnished an additional number for emergency distribution to other offices upon request. Should any postmaster fail to receive a supply of cards by December 24, 1966, or should his supply become exhausted during the reporting period, he should request the nearest office of the Immigration and Naturalization Service to furnish him with the number considered necessary to supply the needs of his office. **THE CARDS MUST NOT BE HANDED OUT PRIOR TO JANUARY 1, 1967.**

6. **Forms to be called for at post office.** The reporting cards will be made available at post office windows of main offices and classified stations or branches to be handed to the alien on request.

7. **Collection and inspection of completed cards.** The completed cards will be turned in to employees at post office windows. **IN NO CASE IS THE CARD TO BE MAILED BY THE ALIEN.** When a completed card is handed to the postal employee, he will examine it to see that the letter and registration number have been entered (Item 2). If the number has not been entered, the card shall be returned to the alien for insertion of the number. If the alien indicates that he cannot

furnish the number, the card should be accepted without it. Damaged cards should be handed back and the alien requested to execute a new card. Postal employees will make no inspection of any information on the card other than Item 2.

8. **Return of completed cards.** Completed cards shall be mailed in official envelopes or packages to the designated Immigration and Naturalization Service offices listed below. No address report cards (Form I-53) will be sent to the central office of the Immigration and Naturalization Service. The envelope or wrapper shall be endorsed, *Address Report Program. The Cards Should Be Mailed at the End of Each Day When the Quantity on Hand Is 50 or More.* Many offices will receive less than 50 cards during the entire period, in which cases only one mailing will be necessary. Cards inadvertently received through collection boxes or otherwise shall be included with other completed cards without examination. Care shall be exercised so that cards are protected in transit. In the larger offices, the original cartons in which the cards were received should be used for mailing them to the Immigration and Naturalization Service. In other offices, when 50 or more cards are mailed at one time, they should be wrapped in paper before being placed in envelopes. Wrapping is essential to protect the long edges of the card; these edges must be undamaged or the cards cannot be processed through tabulating equipment. Completed cards shall not be processed through any canceling or stamping machine in the post office.

9. **Delayed registration.** The official reporting period is January 1 through January 31, 1967. Postmasters must not accept reports after this date. Any alien who attempts to file a report after January 31, 1967, shall be directed to the nearest office of the Immigration and Naturalization Service or be informed that he may mail his report to that office with a letter explaining why his report was not made on time.

10. **Unused cards.** All unused cards must be destroyed at the end of the reporting period (January 31, 1967).

11. **Lobby display.** Posters are currently being distributed for lobby

display in connection with the alien address program. Postmasters are authorized to display these posters in lobbies when received and continuing through the month of January 1967. Postmasters in GSA buildings will request the building superintendents to display the posters at all points where they may be seen by the public. If additional posters are required, request them from the nearest office of the Immigration and Naturalization Service.

Form 1564-B, Orders to Box Section or Other Special Orders

Section 353.31f, Postal Manual, provides that rural carriers will enter orders to box section or other special orders on Form 1564-B.

Where a patron resides in an area served by a rural route but has not erected a box for receipt of mail, the rural carrier will *not* enter the patron's name and correct mailing address on Form 1564-B, unless the patron files written instructions with the post office. In the absence of such written instructions, the rural carrier will endorse the article appropriately and return the mail to the throwback case.—Bureau of Operations, 12-8-66.

Disposition: The following subcommittee report was accepted by the full committee:

Estimated repair time is to be used only as a guideline. It is the responsibility of the supervisor to review the work orders and, if necessary, counsel the employee when estimated repair time has been exceeded. In the event the employee runs into difficulty in performing his work assignment, he should advise his supervisor accordingly and/or note in the "Remarks" portion of the work order the reason for exceeding the estimated repair time. Estimated repair time should not be used as a tool to harass employees.

(9) The Post Office in many of its offices is contracting vehicles that are unsafe to operate. What is the Department's policy in this regard?

Disposition: The Department's policy on contract vehicles requires late model vehicles in excellent mechanical condition and appearance and suitable for the service to be performed. Vehicles must be equipped with seat belts and any other safety equipment in operating condition required by local or State law.

(10) What is the attitude of the Department regarding the aptitude test required of the label-slip-room employees?

Disposition: There is no aptitude test required.—Bureau of Personnel, 12-8-66.

All Post Offices

Addressing Mail for Servicemen Overseas

Mail intended for servicemen at oversea military post offices must be completely addressed to assure prompt delivery. The recently authorized airlift service for letters, post cards, sound-recorded messages and parcels weighing up to 5 pounds and measuring up to 60 inches length and girth combined to all oversea military post offices has greatly reduced the time required for transportation.

However, many letters and other mail continue to be delayed at postal concentration centers by failure of the sender to use a complete address. Some publications also fail to carry full addresses. Mail without a five-digit APO or FPO number, or without identification of the unit or organization or name of ship to which the serviceman is attached must be given directory service.

Postmasters are requested to inform mailers of the need to use complete addresses. If local publishers mail to oversea military addresses, review with them the importance of using complete addresses, including the five-digit APO or FPO number.

The list of former one-, two-, and three-digit APO and Navy numbers and the correct five-digit APO and FPO numbers originally published in the POSTAL BULLETIN of December 10, 1964, is republished below. If local publishers are not addressing copies to five-digit military post office numbers, furnish a copy of this list and request use of the correct number. Explain that any copies directed to the former numbers are considered as incorrectly addressed and notice on Form 3579 will be issued.

All First-, Second-, and Third-Class Post Offices

Supervisory, Specialized, and Noncraft Employees—Seniority Ties

Public Law 89-301 amended title 39, section 3571(d), United States Code, to require, to the maximum extent practicable, the assignment of senior regular employees to a basic workweek, Monday through Friday, inclusive, except for those who express a preference for another basic workweek.

Implementing instructions in the special issue POSTAL BULLETIN of

March 4, 1966, 20520, defined seniority for this purpose as follows:

Seniority is determined on the basis of total service in a salary level and position in a service branch and installation.

Because two or more of these employees sometimes have equal seniority under the definition, **such ties are to be broken in accordance with the following:**

1. In assignments in the initial supervisory salary levels, according to total postal service, except that in the case of a supervisor involuntarily reduced (not for inefficiency or disciplinary reasons) his seniority in the initial level position shall include his total service in any higher salary level.

2. In assignments in higher supervisory salary levels, according to total service in supervisory, specialized and noncraft positions.

This instruction applies when making assignments pursuant to the law. It does not apply to rural carriers, postmasters, employees in PFS-15 and above, or employees assigned to road duty.—*Bureau of Personnel, 12-8-66.*
