

8-Cent Missouri Statehood Commemorative Postage Stamp

The 8-cent Missouri Statehood commemorative postage stamp will be first placed on sale at Independence, MO on May 8, 1971.

POSTMASTERS SHALL NOT PLACE THIS STAMP ON SALE BEFORE MAY 9, 1971

To obtain first day cancellations, collectors may submit requests to the Postmaster, Independence, MO 64051. See Postal Service Manual, section 257.2. Selected mint stamps will be available at the Philatelic Sales Unit, Washington, DC 20036 beginning May 10, 1971. All production will be tagged.

All classes of post offices will receive an initial supply of the stamps under the automatic distribution schedule.

First-class post offices requiring additional bulk quantities should immediately submit a separate requisition (form 3356) to the Bureau of Engraving and Printing using item 441.

All post offices requiring less-thanbulk quantities in addition to the automatic distribution may submit a requisition (form 17) to their designated sectional center facility on their next scheduled requisitioning date... Office of the Special Assistant to the Postmaster General, 4-8-71.

Residence of Postmasters After Appointment; Appointment of Postmasters Under Prior Procedures

Postal Service Order No. 71-4

1. Residence of Postmasters After Appointment

a. Postal Service Order No. 71-3 established new and expanded work location and residence guidelines to govern the selection of postmasters, thereby revoking the residence rules governing appointments contained in former subsections 3312(a) and (b) of title 39, United States Code. Postal Service Order No. 71-4 revokes the residence rules contained in former subsection 3312(c) of title 39, United States Code, which applied to postmasters after they had taken office.

b. It is hereby ordered that no residence requirement shall apply to postmasters, except that they shall not live so far from their work location that they cannot adequately discharge their responsibilities as employees of the Postal Service.

2. Appointment of Postmasters Under Prior Procedures

Notwithstanding the provisions of Postal Service Order No. 71-3, the Postmaster General may, prior to July 1, 1971, approve the appointments as postmasters of individuals recommended by postmaster selection boards prior to the effective date of Postal Service Order No. 71-3 under procedures then in effect.

3. Effective Date

This Order shall be effective on April 1, 1971.

All Postal Installations Advancement to Postmaster Opportunities

Many career employees have been asking questions regarding their opportunities for advancement to postmaster now that residency has been eliminated.

Post offices having vacancies at the postmaster level will continue to be administered through the present postmaster selection program. That means that qualified career employees within the vacancy office will continue to be given initial consideration for the postmaster position.

If a career employee within the vacancy office is not selected and recommended to the postmaster position the extended procedures then take affect. It is through the initiation of these secondary procedures that qualified careerists outside the vacancy office will be given consideration.

No posting or application procedures are included in this process. A systematic approach to candidate identification is being developed which will be ready for initiation in the near future.—Office of the Deputy Postmaster, 4-8-71.




Only sectional center facilities designated to distribute accountable paper and first-class post offices that receive new issue commemorative stamps from the Bureau of Engraving and Printing will be automatically furnished an initial supply of the 8cent American Flag stamp in sheets and coils of 100. The quantity sheet stamps to be furnished automatically will be 5 times the quantity furnished on a 50-subject commemorative stamp, and 200 coils of 100 will be supplied for each package of 5,000 commemorative stamps furnished automatically.

Special Notice to Collectors

Collectors should clearly endorse the outside envelope to the respective postmaster, indicating the issue desired.

How To Requisition

The requisitioning procedures shown below must be followed precisely to assure an equitable supply of the new items for all offices.

Bulk Quantities.—A maximum stock level on bulk quantities applies to both initial and supplemental requisitions, as follows:

Postage stamps—8 weeks Stamped envelopes—6 weeks Postal cards—12 weeks

Supplemental requisitions shall be placed when stocks on hand are reduced to one-half.

First-class post offices shall requisition bulk quantities of postage stamps from the Bureau of Engraving and Printing in the usual manner. All postmasters shall requisition bulk quantity embossed stamped envelopes from the U.S. Stamped Envelope Agency, Williamsburg, PA, and requisiton bulk quantity postal cards from the Government Printing Office.

Less-Than-Bulk Quantities.— Offices requiring less-than-bulk quantities of stamps, airmail postal cards, and airmail embossed stamped envelopes may requisition these items from their designated sectional center facility using a separate form 17 for each new item. The quantity requisitioned shall not exceed a 6-week supply. Each of the new issues will be available at the Philatelic Sales Unit, Washington, DC 20036, following the respective first-day sales, except that the 8-cent American Flag and 16-cent Ernie Pyle stamps will be available at the PSU on the day of first-day sale.

Supplies for Self-Service Post Offices

The items listed below are available only to offices having multicommodity vending machines. These special items are for sale only in selfservice post office vending machines and are not to be sold across the counter:

Banded postal cards are packaged in units of 10 6-cent cards, item 286, and sell for 60 cents. Order in minimum lots of 5,000 cards. Enclose a memorandum indicating that the order is to be filled with banded stock for sale at your SSPU.

Banded stamped envelopes, size 6¾, 8-cent envelopes, item 681, are banded in units of 10 envelopes and sell for \$1. Size 6¾, 11-cent airmail stamped envelopes, item 614, are banded in units of five envelopes and sell for 65 cents. Order in minimum lots of 5,000 envelopes. Enclose a n.emorandum indicating that the order is to be filled with banded stock for sale at your SSPU.

The \$1 airmail book is for both vending machine and across-thecounter sales.

Air Travel—Denied Boarding Compensation

Travelers not afforded accommodations for which they hold confirmed reservations should make demand upon the carrier's agent for penalty payments in accordance with the "Denied Boarding Compensation Plan" governing most scheduled airlines.

Check covering such penalties should be made payable to the U.S. Postal Service and forwarded to the appropriate postal data center with the travel voucher or with a statement describing the circumstances and the serial number of the transportation request used to purchase the ticket.

If a traveler receives a check in his own name covering such a penalty payment, he shall endorse the check for payment to the U.S. Postal Service and turn it in with his travel voucher or with a statement describing the circumstances and the serial number of the TR used to purchase the ticket.

The data center will debit the cash account and credit the expense account originally charged with the cost of the related TR.—Finance and Administration Department, 4-8-71.

To All Postmasters Affiliated With Local and Area Mail Users Councils

Postal Customers Councils

In keeping with our efforts to introduce a "customer" orientation to the Postal Service, we are changing the name of the Mail Users Councils. Henceforth, they will be known as **Postal Customers Councils**.

The chairman of each local and area council is being advised by letter of this change in name. New membership certificates are being designed and will be issued as soon as possible.

Although the change to Postal Customers Councils may cause some problems for some of the Councils, the identification as "customers" will be worth the momentary inconvenience.

Section 361.37 of the Postal Service Manual will be amended to reflect this change.—Planning and Marketing Department, 4-8-71.
