

# Requisitioning Publications and Handbooks

Official Postal publications and handbooks must be requisitioned on Form 1286, Request for Postal Publications (submit in duplicate).

Order non-revisable publications and handbooks; i.e., ones that are not looseleaf, directly from your area supply center.

Order *revisable* publications and handbooks; i.e., looseleaf ones that are revised by transmittal letter, through the Directives Control Division, U.S. Postal Service, Washington, DC 20260. The Directives Control Division maintains the mailing lists for all revisable publications. Supply centers do not maintain mailing lists.

One-time orders for additional copies of a particular Postal Bulletin or particular Postal Service Manual issue may be requisitioned on a separate Form 1286 directly from the Eastern Area Supply Center, Somerville, NJ 08877. Neither of these items is stocked at the Western Area Supply Center.

In each postal installation there should be someone authorized to control the distribution of publications. That person is responsible for keeping accurate quota records for each publication-especially revisable ones. Quota information should be shown on each Form 1286 in the spaces provided, even though no quota change is needed. This information is used by the Directives Control Division to maintain up-to-date mailing lists and assure the automatic distribution of future issuances in correct quantities. Each request is to be signed by the person authorized by the head of the installation. Requisitions submitted by unauthorized personnel will not be honored.

Additional information concerning publications and handbooks available, source of supply, etc., will be incorporated in Pub. 24, Supply Catalog, when it is revised.—Operations and Finance Groups, 3-6-75.

# 10-Cent Mariner 10 Commemorative Stamp

**Description.** The 10-cent Mariner 10 commemorative stamp will be first placed on sale at Pasadena, CA 91109, April 4, 1975.

Do Not Sell Before April 5, 1975.



Image area: 1.44 x 0.84 inches. Issued in sheets of 50. Colors: Blue, brown, red and black. Marginal markings: One plate number, Mail Early and Mr. Zip. Initial printing: 140 million. Designer: Roy Gjertson.

**Collectors.** Request first-day cancellations from: Mariner Stamp, Postmaster, Pasadena, CA 91109 (see PSM, section 257.2). Selected mint stamps will be available at the Philatelic Sales Division, Washington, DC 20036, beginning April 5, 1975.

Supply. All classes of post offices will receive an initial supply of the stamps under the automatic distribution system. Before requisitioning additional stamps (Item 411), consider that the stock should be depleted prior to June 4, 1975 at all post office outlets except designated philatelic windows and postal stores.

First-class post offices requiring additional bulk quantities: immediately requisition on Form 3356 from the Bureau of Engraving and Printing.

First-class post offices requiring additional stamps in less than bulk quantities and all other post offices: requisition on Form 17 from designated SCF on next scheduled requisitioning date.

**Panels.** A limited number of  $8\frac{1}{2}$  by 11¼ inches commemorative series stamp panels will be released with the stamps. The panels (**Item 966**) are printed on heavy art paper suitable for mounting and sell for \$2 each.

## Issue 94, PSM

There was a mixup in the mailing of Issue 94, Postal Service Manual. Some officers did not receive their full quota in the first mailing. A supplemental mailing is being made. Do not order Issue 94 unless you have not received your full quota by March 3, 1965. # **Apartment House** Mailbox Label

Sign 49-A, intended for use on apartment house mailbox units, has been redesignated Label 33. This label with bold red lettering, warns of the penalty (fine and/or imprisonment) for tampering with locks or boxes and theft of mail from mail receptacles. This notice has been revised to include the wording: DO NOT LEAVE MAIL HERE; DE-POSIT IN COLLECTION BOX. See exhibit A.

Label 33 Dec 1974

These labels are to be used first in areas where there has been a problem with theft and/or vandalism. They should be applied as near as possible to the arrow lock on units with master doors, or the top center of horizontaltype rear-loading installations.

Offices having a need for these labels may order them from their area supply center on Form 7380, Requisition for Supplies, during regular requisitioning cycles.-Delivery Services Department, 3-6-75.

## **Customs Documentation**

This is to correct Postal Bulletin 21025, 2-27-75, page 5, Preparation of Foreign Parcels.

All parcel post packages destined for foreign countries must bear one (1) Form 2966-A, Parcel Post Customs Declaration (adhesive). In addition, parcels destined for some foreign countries require Form 2972, Dispatch Note, and/or Form 2966, Customs Declaration (tie-on tag).

The appendix of Publication 42, International Mail, contains, under each country, a list of the forms required by that country. Missing customs forms can delay the delivery of the parcel in the foreign country or cause its return.-Rates and Classification Dept., 3-6-75.

# International Inaugural Service

Lufthansa German Airlines has advised that it will inaugurate DC-10 service as follows:

(1) On or after April 9, 1975, from New York to Lima, Peru; La Paz, Bolivia; and Santiago, Chile. Affix postage at 21 cents per half ounce to covers for these destinations. Please identify covers as to which city backstamping is desired.

(2) On or after April 10, 1975, Lufthansa will inaugurate service from New York to Frankfurt, Germany. Affix postage for this service at 26 cents per half ounce.

Official cachet and philatelic treatment is authorized for both services as outlined in section 257.33 Postal Service Manual. To send covers by these services, prepare them in the usual manner addressed for delivery in Peru, Bolivia, Chile, Germany, the United States, and Canada AERO-GRAMMES AND POSTAL CARDS WILL NOT BE ACCEPT-ED.

Mail covers to reach the office applying the cachet at least 3 days prior to the scheduled date of the flight. Enclose covers in another envelope addressed as follows:

# Suspension of Military **Postal Service Privileges**

The Department of Defense has advised that military postal system (APO/FPO) support to non-Department of Defense contractors and to volunteer charitable organizations which are not sponsored by or working in direct support of the Department of Defense has been, or is in the process of, being terminated because there is no authority for that Department to provide military postal support to such organizations. In each case the organization or contractor has been provided with 90 days' notice of discontinuance in order to afford them time to notify their correspondents and publishers of their new mailing address. Upon expiration of the 90 days' notification, such mail will be marked for return to sender by military postal personnel and will be endorsed Not Authorized Military Postal Service. Customers who complain or inquire regarding the return of such mail should be so informed.-Rates and Classification Dept., 3-6-75.

## **Restricted Delivery Mail**

Customers who regularly receive Restricted Delivery mail may choose to authorize an agent by use of the Form 3801, Standing Delivery Order. The name of the person designated as agent is to be entered in the first block on the form and the addressee then must sign and date the form in the second block. The notation "for Restricted Delivery" should be made by the addressee on the part of the form provided for signatures of authorized agents. This form is kept on file at the post office. It is only to be used as authorization for Restricted Delivery mail addressed to an individual. A business firm may not use one form, for example, to authorize an agent to receive Restricted Delivery mail addressed to more than one company officer.

A third method of authorizing an agent to receive Restricted Delivery mail is by ordinary letter from the addressee to the postmaster to be kept on file at the post office.

If a return receipt (Form 3811 or 3811A) has been requested by the mailer, be sure a signature is also obtained on the return receipt and that the form is dated.-Rates & Classification Dept.-3-6-75.

# Deficiencies

Some security containers, items 293, 294, 296 and 298, manufactured by the Schwab Safe Company, have been found to have insecure interior locked cabinets. In these cases, the interior compartment locks were mounted too far away from the door strike to fully engage the locking bolt. All lockable compartments on Schwab containers should be tested to insure that they cannot be surreptitiously pried open, thereby exposing contents to theft. Corrective action can be taken locally by mounting a plate 3/8" by 1/4" by 1/16" behind the door strike. In cases where the distance is excessive, a plate thicker than 1/16" should be used.

In addition, a small number of Schwab security containers manufactured during Fiscal Years 1969 and 1970 have been found to have faulty hinge pins on the outer door. This deficiency causes metal fatigue in the hinge pin which can break off and cause the door to fall off.

Hinge pins on all Schwab security containers received before 1971 or bearing a manufacturer's date prior to 1971 should be replaced as soon as practicable. See Maintenance Bulletin PE-22-72(MA) entitled Security Containers-Schwab, Types 239 to 298 dated September 5, 1972. # International Registered **Postal Union Mail**

## Payment of Indemnity, Inquiries and Claims

In some cases postal employees are misinforming customers of the indemnity payable in the event of the loss of international registered mail. With the exception of Canada, the maximum indemnity for the loss of international registered mail to all countries to which this service is available is \$15.76. Payment is made in any amount claimed, regardless of value or lack of value, not to exceed \$15.76. The maximum indemnity for registered mail exchanged with Canada is \$200 and is based on actual value. For specific conditions of indemnity payments see 722.1, Publication 42, International Mail.

Inquiries as to disposition, complaints of loss, rifling, damage, delay or wrong delivery of international registered mail are reported on Form 1510 for mail exchanged with Canada and Form 542 for mail exchanged with all other countries. See 715.11 and 715.21, Publication 42, International Mail, for complete instructions. Claims for indemnity (Form 565) are instituted only after the completion of the inquiry and on instruction from the postmaster at the appropriate adjusting exchange office shown in 722.6, Publication 42, International Mail.-Rates and Classification Dept., 3-6-75.

## Memorandum of Understanding

The United States Postal Service and the American Postal Workers Union, AFL-CIO have reached agreement on the long pending issue of flexible relief work cycle scheduling. The Memorandum of Understanding provides a method for management retention of the necessary flexibility in scheduling while providing full-time employees with such schedules with some degree of predictability. Through careful attention to scheduling, local management should be in a position to schedule efficiently in accordance with the Memorandum.

The Memorandum of Understanding is printed in full as follows:

## MEMORANDUM OF UNDERSTAND-ING CONCERNING USE OF FULL-TIME EMPLOYEES ON RELIEF AND POOL ASSIGNMENTS

Relief and pool assignments, sometimes called "flexible relief work cycle" assignments are utilized to cover absences of employees holding regular bid assignments and other situations where the assignment is uncovered. Such relief and pool assignments also enable management to accommodate employee requests for unscheduled leave. It is recognized that the concept of a relief or pool assignment necessarily entails a degree of uncertainty in scheduling employees filling such assignments.

In order to minimize this uncertainty, the parties have agreed to the following principles to be applied to the establishment and operation of relief and pool assignments:

1. The Postal Service may establish new or additional relief and pool assignments in any installations. The Postal Service shall consult with the Union before management makes a final decision with respect to the establishment of such assignments in any installations where they do not presently exist.

2. Relief and pool assignment postings will specify the nature of the assignment by enumerating the type and location of assignments to be relieved; e.g.

"the pool employee will cover absences of window employees assigned to classified stations and branches, as well as main office windows."

The degree of specificity included may vary with the size of the installation in that in some offices with a large relief pool a particular relief assignment could be limited to a relatively small area of coverage, whereas in other offices the nature of the assignment may have to be broader.

3. Relief and pool assignments will have fixed days off, which may be on a rotating basis.

4. Relief and pool assignments will have fixed hours. However, hours of duty may vary from day to day; for example:

Monday, 6:00 a.m.-2:30 p.m. Tuesday, 9:00 a.m.-6:00 p.m. Wednesday, 12:00 noon-8:30 p.m. Thursday, 8:30 a.m.-5:30 p.m. Saturday, 6:00 a.m.-3:00 p.m.

5. An employee holding a relief or pool assignment, as described above, will be paid at the overtime rate for those hours worked which are outside his normal, regularly scheduled workweek, except under the following circumstances:

(a) When management informs the employee that he is to cover an assignment having a schedule different from the relief or pool employee's regular schedule for a period of one week (five working days) or longer, the relief or pool employee will assume the new schedule and will not receive overtime pay for those hours worked in such new schedule which are outside of his normal regular schedule. However, the relief or pool employee will be entitled to overtime pay for those hours worked outside of his normal, regularly scheduled workweek (i) unless and until management informs him in writing that he is to work a new schedule for a week or longer, or (ii) if the relief or pool employee in fact works the new schedule for less than a week after he is so informed by management; or

(b) When management tells him to perform functions which predictably occur at the end of an accounting period; e.g., those of Timekeeper or Civil Service Examiner.

# Mail for National Society for Crippled Children and Adults

The simple form of address Easter Seals, c/o Postmaster will be used during the national fundraising event scheduled by the National Society for Crippled Children and Adults from the present through March 30, 1975. The local ZIP code must be included as a part of the simple form of address.

All mail addressed to Easter Seals, c/o Postmaster (local ZIP code) received at any post office in a State must be forwarded daily to the postmaster of the central city post office shown opposite the name of each State as published in the article, Mail for Muscular Dystrophy Association, Inc., in POSTAL BULLETIN 21007, dated 10-24-74. Three or more pieces of mail forwarded at the same time should be sent under cover of a penalty envelope or label. Shortpaid or unpaid pieces must be rated with the deficient postage.

The mail must be delivered by the central city postmaster to the authorized representative of the National Society for Crippled Children and Adults in accordance with the written instructions received by him from the society's national headquarters. Any deficient postage must be collected upon delivery.—Rates & Classification Dept., 3-6-75.

## Special Cancellations Easter Seals

Postmasters who have special Easter Seals cancellation die hubs shall use them immediately through March 30, 1975. After that time the die hubs shall be withdrawn and retained for future authorized use. Postmasters who do not have special die hubs shall not request them without application by the sponsors.

#### **Red Cross**

Postmasters who have special Red Cross cancellation die hubs shall use them immediately through March 31, 1975. After that time, the die hubs shall be withdrawn and retained for future authorized use.— Rates & Classification Dept., 3-6-75.

Scheduling and posting of fulltime employees in relief or pool assignments should be immediately brought into compliance with this Memorandum of Understanding.— Operations Group, 3-6-75.

The postal authorities of Poland have reported that many parcels from the United States bear illegible and/or incomplete customs declaration Forms 2966-A, Parcel Post Customs Declaration (Label), and 2966, Parcel Post Customs Declaration (Tag). Delivery of these parcels is delayed in Poland.

When parcels are presented for mailing to Poland and to all other countries, they should be checked for legible and complete customs declarations. See section 314.1, Publication 42, International Mail.—Rates and Classification Dept., 3-6-75.
